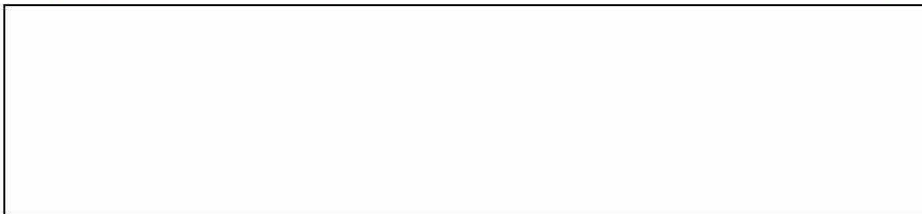
I spoke to Owen and Phil's folks about this. I've already had the good ones I know about faxed over to both their judiciary committee staffers and CoS.
