Dear Brett:

As we have worked together for the past several years, I have refrained from making any recommendations to you or the Administration about who should be appointed as a federal judge. As you might imagine, rarely a month goes by without someone asking me to do so. Either because I did not know the person well or because I felt his or her qualifications did not meet the Administration's standards, I have made no recommendations.

By way of contrast, it is a professional pleasure for me to know of someone who would meet the Administration's high standards and would make an extraordinary federal judge. That person is Stephanie A. Middleton, Esquire, currently the Chief Litigation Counsel at CIGNA Corporation, headquartered in Philadelphia. My understanding is that there will be a number of vacancies in her geographic area, due to some federal district judges and Judge Becker on the Court of Appeals for the Third Circuit taking on senior status.

The Senators Specter-Santorum panel has reviewed Ms. Middleton's candidacy. When I learned of this fact, I asked Ms. Middleton if I might write you. I was pleased when she said yes.

I first met Ms. Middleton in 1985, when she was a Senior Counsel at CIGNA. After working with her on some matters, I told CIGNA's then General Counsel, Tom Wagner, "Tom, you have a winner there!" At the time, there were very few women attorneys working for CIGNA. It was comforting to meet and work with a potential star.

As a former law professor, much of my life has been spent assessing legal talent. In this case, my judgment about Ms. Middleton proved to be correct. As you will see from Ms. Middleton's resume, she has had just the right balance of experience to be an excellent judge: private practice, government (working as a Deputy General Counsel to Governor Tom Ridge), and in her present position at CIGNA. Her current responsibilities are broad and significant. She manages all litigation for CIGNA – commercial disputes to class actions to antitrust and employment matters. She advises the company on audit matters and the corporate security department on fraud issues. She has oversight of the company's Human Resources Division.

I have worked hand-in-hand with Ms. Middleton when the company has faced serious legal challenges. I have been impressed by her disciplined approach, and her skill in reasoning through problems and making sound and effective decisions. The people who work with her respect her, and that – as you can appreciate – is an essential ingredient for an effective federal judge.

Of equal importance is that Ms. Middleton is a good listener, and she is fair. Her judicial philosophy is sound; I do not believe that she is an “activist.” On the other hand, she is not a rote legal machine. She is a person with creative abilities who would use them when they are needed. She understands the appropriate roles of judge versus legislator.

I appreciate your taking the time to allow me to share these thoughts with you, and would be pleased to further discuss Ms. Middleton’s merits, should it be helpful to you or others at the White House.
