This FOIA primarily contains photographs of President George W. Bush and former President George H.W. Bush following their interview with historian Richard Norton Smith in the Grand Foyer of the White House on January 19, 2009. The photographs include posed group photos with both Presidents and various White House staff, as well as candid shots of President George W. Bush and former President George H.W. Bush greeting and talking with staff.

**System of Arrangement**
