**Abstract:** Claude served as Assistant to the President from January 2005 - February 2006 in the Domestic Policy Council. This collection contains materials related to the response to Hurricane Katrina, administrative materials, and a large quantity of policy making material on a variety of topics including education, health care, housing, marriage and family issues, the usage of stem cells, poverty, space exploration, Title IX, transportation, reform of the United States Postal Service, and veterans' issues. Some material in this collection was created and/or used by Margaret LaMontagne Spellings, Allen's predecessor, from 2001-2004.

**Biographical History:** Claude Allen was born in Philadelphia, Pennsylvania. He primarily grew up in Washington, D.C., where he attended Archbishop Carroll High School. He went to college at the University of North Carolina at Chapel Hill, earning degrees in political science and

linguistics. He later studied at Duke University School of Law, graduating with both a Juris Doctorate and a Master's of Law in international and comparative law.

Allen held numerous positions before serving in the George W. Bush administration. He worked for North Carolina politicians Bob Cobey and Jesse Helms. From 1985-1987, he was a professional staff member of the Senate Foreign Relations Committee. Following that, he was a U.S. Circuit Court of Appeals law clerk. From 1991-1995, he worked as an associate at Baker & Botts law firm in Washington, D.C. Allen served as Counsel to the Attorney General, and later, Deputy Attorney General for the Civil Litigation Division in the Office of the Attorney General of the state of Virginia. Lastly, Allen was Secretary of Health and Human Resources for Virginia.

Allen joined the George W. Bush administration in 2001. He served as the Deputy Secretary of the Department of Health and Human Services (HHS) until the end of 2004. In late 2003, he was nominated to serve as a federal judge on the Fourth Circuit Court of Appeals. This nomination stalled and he was never confirmed. He left HHS and became the Assistant to the President for Domestic Policy, or the head of the Domestic Policy Council, in January 2005. On February 9, 2006, Allen resigned from this position citing the need to spend more time with family. Allen's resignation was presumably motivated by his impending arrest for fraudulently returning items to retail stores on multiple occasions. On August 6, 2006, Allen pled guilty to charges of theft, was placed on probation, required to perform community service, and paid a fine.

Allen has an identical twin brother, Floyd. He is married to Jannese Allen; they have four children. He is described as a devout Christian.

**Scope and Content Note:** The collection is arranged in four series – Meeting Files, Administrative Files, Hurricane Katrina Files, and Subject Files. Each series is arranged alphabetically.

The series Meeting Files is unprocessed and not currently available for research.

The series Administrative Files is unprocessed and not currently available for research, except for two folders. These folders contain administrative travel documents and an invitation.

The series Hurricane Katrina Files consists of documents that were primarily created immediately following Hurricane Katrina. These materials detail the status of various components of infrastructure and the recovery activities occurring in the impacted areas. Allen served as the official White House liaison to federal agencies for Hurricane Katrina response. Also included are agency and outside organization reports regarding recovery activities, correspondence and proposals from groups attempting to become involved in the rebuilding and recovery process, listings of which federal agencies are involved with what aspects of rebuilding, and information regarding the implementation of the National Response Plan.

The series Subject Files consists of fact sheets, correspondence, cover sheets, routing memoranda, talking points, printed emails, news articles, legal documents, presentations, final remarks, published reports, and promotional material from organizations. Correspondence includes letters from Congress, letters from organizations with proposals and information regarding those organizations, invitations, and letters expressing policy viewpoints from the public, think tanks, and lobbying organizations. The topics covered include a wide-array of domestic policy issues such as education, health care, housing, marriage and family issues, the usage of stem cells, poverty, space exploration, Title IX, transportation, reform of the United States Postal Service, and veterans' issues. A significant portion of material (50% or more) in this series appears to have been created by and/or used by Allen's predecessor as Assistant to the President for Domestic Policy, Margaret LaMontagne Spellings, in 2001-2004, as Allen was serving at HHS during that time period. Although all records were retired in boxes labeled with Claude Allen's name, it is possible to identify what folders are from which staff member by using the following information: Spelling's handwriting is usually in cursive with a very fine point pen, whereas Allen's writing is generally thicker and in both print and cursive. Allen's assistant was Cameron Cushman and Spelling's assistant was Eleanor Gilmor and emails and cover sheets are routed through them. The date range of 2001-2004 consists of Spellings material and the date range of 2005-2006 consists of Allen material.

**System of Arrangement:** The collection is arranged in four series. Each series is arranged alphabetically.

Series 1, Meeting Files – Boxes 2-6 are unprocessed.

Series 2, Administrative Files – This series is unprocessed, except for two folders.

Series 3, Hurricane Katrina Files

Series 4, Subject Files

This collection is only partially processed and some boxes may be unavailable for research.
