Scope and Content

The materials in FOIA 2021-0018-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2021-0018-F requested materials related to the audio recording or transcript of the September 11, 2001 White House radio communication system warning or documents discussing the recordings.

This FOIA primarily contains interview transcripts, administrative email about notifications and evacuations, and email concerning a written request from the Commission for the Crisis Center Incident Monitor.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2021-0018-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House’s electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

ARMS contains 20 assets, all of which are released in full.

Exchange contains 10 assets, of which 8 are released in full, 2 are withheld in part, and 0 are withheld in full.
