#### **Extent**

#### **Access**

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

#### **Scope and Content**

The materials in FOIA 2018-0263-F[25] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[25] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing pregnan\* between July 2003 and May 2006.

This FOIA primarily contains draft and annotated speeches, telephone call script drafts, draft presidential statements, draft correspondence, memoranda, draft and final reports, night notes, moot court background materials, draft legislative bills, and news articles. Notable topics in this segment include 2006 State of the Union draft materials, policy discussion of Hurricane Katrina,

documents related to Secretary of State Colin Powell's determination regarding funding of the United Nations Population Fund, discussion of China's birth limitation policy, memoranda on women's issues in 2004, and questions asked during Supreme Court nomination hearings. Records from this segment date from October 10, 2003 to June 15, 2006.

### **System of Arrangement**

The materials in FOIA 2018-0263-F[25] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

Pregnan Exchange\_5 contains 181 assets, of which 135 are released in full, 32 are withheld in part, and 14 are withheld in full.

Pregnan RNC PST\_1 contains 137 assets, of which 39 are released in full, 9 are withheld in part, and 89 are withheld in full.
