This FOIA primarily contains White House News Summaries and Clips, press background briefing information, State Department weekly cabinet reports, presidential remarks, and an email from nominated Ambassador to India Robert Blackwill.

System of Arrangement

The materials in FOIA 2021-0121-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

George W. Bush Electronic Records

ARMS contains 41 assets, of which 17 are released in full and 24 are withheld in part.

RNC contains 26 assets, of which 20 are released in full and 6 are withheld in part.
