Scope and Content

FOIA 2021-0162-F requested video footage of the Los Angeles Lakers visiting the White House on January 28, 2002.

This FOIA primarily contains video footage of a photo opportunity with the Los Angeles Lakers on January 28, 2002, in the East Room of the White House. Video footage also depicts remarks by President George W. Bush on the Lakers' championship win, remarks by coach Phil Jackson, a jersey presentation by Kobe Bryant, and a basketball presentation by Shaquille O'Neal.

System of Arrangement

The materials in FOIA 2021-0162-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
