#### **Extent**

252 assets

#### **Access**

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

#### **Scope and Content**

The materials in FOIA 2018-0263-F[44] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[44] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing abort between July 2003 and May 2006.

This FOIA primarily contains news articles, night notes, cabinet reports, comment line reports, talking points, and moot schedules. Most records relate to Harriet Miers' and Samuel Alito's Supreme Court nominations. Records from this segment date from September 4, 2005 to December 27, 2005.

### **System of Arrangement**

The materials in FOIA 2018-0263-F[44] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
