#### **Scope and Content**

FOIA 2021-0036-F requested video footage from tapes WHTV 594 09/11/2001 Karen Hughes Statement and WHTV 595 09/10/2001 Arrivals, Departures and OTRs Tape #1 - Trip to Florida.

This FOIA contains seven video clips from tapes WHTV 594 and WHTV 595. Tape WHTV 594 includes footage of a statement by Karen Hughes from the FBI building in Washington, D.C. on September 11, 2001. Tape WHTV 595 includes footage of arrivals and departures of Air Force One during a trip from Washington, D.C. to Florida on September 10-11, 2001. Footage also includes President George W. Bush jogging at Longboat Key Club in Longboat Key, Florida on the morning of September 11, 2001.

### **System of Arrangement**

The materials in FOIA 2021-0036-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
