Judging Gonzales |

Conservatives worry about Bush's Supreme Court |

Is White House counsel Alberto Gonzales on the short list to fill the next Supreme Court vacancy? That's been the subject of speculation since even before President Bush took office. That speculation had declined in recent months, and a recent Washington Post story suggested he was out of the running. But the rumor mill is up and running again. Some social conservatives are reporting that the White House is trying to sell them on Gonzales's merits. They're worried that a Justice Gonzales could be in our future.

In the Senate, Republican staffers who share this alarm have taken to saying that "Gonzales is Spanish for

Souter." The reference is to Justice David Souter, a nominee of the first President Bush. Souter was picked because he lacked a paper trail and could thus easily be confirmed. Souter got 90 votes in the Senate. But on the bench he turned out to be a fairly reliable liberal vote.

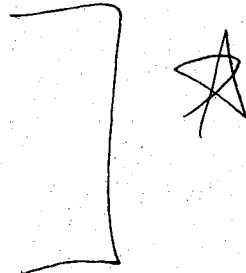
In the latest issue of NR, my colleagues editorialize that it is unfair to compare Gonzales to Souter: "When Souter was nominated, we didn't know anything about his views. We do know something about Gonzales's views, and what we know is not encouraging."

Gonzales opponents say there are two strikes against him. The first is that he weakened the administration's brief to the Supreme Court in the University of Michigan racial-preference cases. Solicitor General Ted Olson wanted the administration to say that the use of racial preferences to achieve diversity is constitutionally impermissible. Gonzales overruled him.

The second strike is Gonzales's record on abortion as a justice of the Texas supreme court. The state had passed a law requiring parents to be notified before a minor could get an abortion. That law, like most parental-notification laws, allowed judges to waive the requirement if observing it could be expected to lead to the abuse of the girl in question. In its first cases dealing with the law, the court read this judicial-bypass provision broadly ? so broadly that one dissenter furiously charged that the law had been gutted.

Priscilla Owen, whom Bush has nominated to a federal court of appeals, sat on the Texas supreme court with Gonzales during the notification cases. She was a dissenter, and last year her opponents seized on a remark Gonzales made in the cases to cast her as an extremist. Gonzales had supposedly tagged Owen as a right-wing activist. Some conservatives believe that Gonzales made this remark, and hold it against him. It appears, however, that Gonzales was referring not to Owen but to one of their colleagues on the Texas supreme court.

I reviewed Gonzales's opinions (and those of his colleagues) for a profile of him in NR two years ago. My conclusion was that while the dissenters had the better argument about how to construe the statute, the cases do not prove Gonzales to be a lawless judge, a supporter of Roe v. Wade, or even a proponent of a



right to abortion. On the other hand, nothing in Gonzales's jurisprudence in that case or others would lead people to believe that he would be a Supreme Court justice in the mold of Antonin Scalia or Clarence Thomas ? which is what Bush said he wanted on the campaign trail.

So far, the White House campaign for Gonzales has found few takers among social conservatives or legal conservatives generally. Some of the former are regularly discussing what to do if Bush nominates Gonzales.

The short answer is that there's not much they would be able to do to stop Gonzales's confirmation. Social conservatives would feel betrayed ? the rank-and-filers, that is, not just the leaders of the Washington groups ? since the chief reason they were given to vote for Bush was that he would nominate "strict constructionists" like Scalia and Thomas. But Republican senators are not going to vote against a Bush nominee who's also the first Hispanic nominee to the Supreme Court, whatever conservatives say. Conservative opponents of Gonzales will have to be careful not to threaten more than they can deliver.

Two months ago, Jeff Bell, an influential social-conservative activist, told me how he thought a Gonzales nomination would play out. "Every article would say that the pro-life movement is over," he said. "[Gonzales would] make [his non-conservatism] obvious as early as the hearings. Leahy would whisk him through, a handful would vote against him. It'd be 90-10. It would be seen as a complete victory for the other side on every difficult liberal-conservative issue before the Supreme Court. . . . Gonzales is not going to resist the zeitgeist on anything for any length of time and everybody knows that. I think it's a major risk for Bush to make a nomination like that and I think he won't. It might not hurt short-run but in the medium-run and long-run it is very dangerous to his base."

Bell could be wrong about the danger. Everyone can understand the political point of nominating the first Hispanic Supreme Court justice and avoiding a confirmation fight with the Democrats. Says one opponent, "If I was just a Machiavellian Republican, without any desire to do the right thing, I'd try to make this thing work." If Gonzales is nominated, however, it will be hard to see what the point of all the pro-life positions that Bush has taken was.

The president has run real political risks in standing with pro-lifers on stem cells, cloning, and international family-planning funding. He has gained their enthusiastic support as a result ? and that's all he has gained. Nominating Gonzales this year would instantly wipe out that enthusiasm. Gonzales's nomination would also raise another question: What was the point of Bush's nominating Scalia-Thomas-style conservatives to the federal courts of appeal? If Bush thought it was worth fighting with liberals over those courts, why not over the court to whose precedents they are bound?

Perhaps the point of all these moves was to build up Bush's credibility among pro-lifers to the point that they would give Gonzales the benefit of the doubt as Bush's friend. But pro-lifers have several reasons not to give Supreme Court nominees the benefit of the doubt. They have been burned before. Pro-lifers were bitterly disappointed with Justices Sandra Day O'Connor, Anthony Kennedy, and Souter, all of whom were nominated by political allies and expected to vote against Roe, but didn't. Another such disappointment would leave the court split 7-2 for Roe. That's the same as the original vote for it. We'd be right back to 1973.

Some people believe that it would be easier to sell conservatives on Gonzales as a replacement for Justice O'Connor than as a replacement for Chief Justice William Rehnquist. The White House could tell conservatives that trading O'Connor for Gonzales was a step up, even if Gonzales is not conservatives' ideal justice. That won't work for everyone: Bush's promise was to appoint "strict constructionists," not to improve the Supreme Court incrementally. It might, however, work for a lot of conservatives ? especially if Bush had already gotten a conservative justice confirmed and Gonzales were his second nominee.

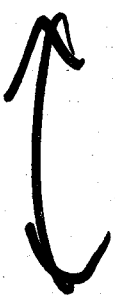

SUBJECT: Federal Employee Health Benefits Plan

The following is a brief summary of the Federal Employee Health Benefits Program. It follows the list of questions put forward by Karl:

When was it adopted?

September 28, 1959. The new law—the Federal Employee Health Benefits Act of 1959—actually went into effect on July 1, 1960.

What was the roll call?

On July 16, 1959, the Senate passed the bill 81 to 4. All four nay votes were Republicans.

On September 1, the House passed the bill 383 to 4. One Democrat and three Republicans made up the opposition.

The conference report was accepted by voice vote by the Senate on September 10 and by voice vote by the House on September 14.

What were the arguments on both sides?

The Federal Employees Health Benefits Act of 1959 established a pre-paid, voluntary health insurance plan for two million federal government workers and their families with the costs to be shared equally by the government and the beneficiaries.

The origins of this legislation can be found in 1954 when President Eisenhower first proposed a health insurance program for federal workers. However, the 1959 legislation was initially opposed by the Eisenhower administration for budget reasons. Eisenhower had requested that the new program not exceed \$80 million. In addition, Eisenhower did raise one structural objection to the plan: he wanted the federal government to cover one-third, rather than one-half, of the cost of health insurance for federal employees. As the momentum for the bill gathered, Eisenhower agreed to the 50-50 split and also said he could live with a \$100 million price tag. In the end, Eisenhower chose to be part of the windshield instead of the bug and signed the final bill that included an estimated \$107 million cost.

In support of the bill, both Republicans and Democrats pointed to the private sector to demonstrate how employers were beginning to include health insurance as part of their employees' payment packages. Senator Richard Neuberger (D-OR), one of the co-authors of the bill, said that the government was lagging behind businesses when it came to providing health insurance to staff.

Dear President Bush,

As a group of leading organizations dedicated to reducing the spread of HIV/AIDS and improving women's health worldwide, we are heartened by the proposal outlined in your State of the Union address to dramatically increase U.S. funding in response to the HIV/AIDS pandemic. However, we are deeply disturbed to learn that the Administration is contemplating an expansion of the so-called Mexico City policy to cover some or all international HIV/AIDS funds, thereby disqualifying from U.S. funding many organizations positioned to be key partners in carrying out your "Emergency AIDS initiative." Any such restrictions can only impede progress in the battle against HIV/AIDS and erode the good will generated by the Administration's renewed commitment to funding HIV/AIDS programs.

It is our understanding that organizations using an integrated public health approach to prevent the spread of HIV and to treat and provide care for people living with AIDS will be disqualified under the expanded policy. This is indefensible. Governments and leading donor institutions throughout the world strongly support integrated family planning and HIV prevention programs as the best approach to improving public health. The World Health Organization (WHO) Global Sector Strategy for HIV/AIDS underscores that existing family planning programs "provide a clear entry point for the delivery of HIV/AIDS interventions." USAID, the World Bank, the European Union and other leading donors in every region encourage integration as a matter of good public health practice and economic efficiency.

For women, access to integrated programs and services can make the difference between life and death. Women now represent half of those infected with HIV worldwide and 58 percent of those in Sub-Saharan Africa where the AIDS epidemic has taken the greatest toll to date. Integrated services offer women confidential outlets for voluntary counseling and testing, referrals for or direct provision of prevention of maternal-to-child transmission (MTCT), and treatment of other diseases. In addition, these services provide accurate information on sensitive issues, such as whether and how HIV-positive mothers can safely breastfeed their newborns; confidential access to MTCT; and a source

of information and resources free from the stigma frequently associated with stand-alone HIV prevention programs. Such services are pivotal to preventing new infections and to improving the survival rates of those infected, while addressing other urgent public health priorities.

We represent a broad spectrum of organizations with a range of specific interests and points of view, but stand unified in our resolve to expedite U.S. assistance to those most affected by the HIV/AIDS epidemic. At this critical time it is urgent to eliminate barriers to effective programs not erect new ones. We therefore oppose any expansion of the "Mexico City" policy and urge the Administration in the strongest possible terms to abandon its plan to expand these restrictions in any form.

Also attending will be the President of Israel, Moshe Katsev. Tentatively, the President of Germany is also planning to be present.


At the 50th Anniversary commemoration, Vice President Al Gore represented the United States.

▶ The second and more serious problem is that neither author can resist inflating their subject's influence. It is not enough that Mr Rove is a successful consultant; instead, he is the "co-president", a scheming genius who took a witless dauphin and scripted every stage of his rise to power.

But who is the monkey and who is the organ-grinder? Mr Rove is more or less excluded from foreign policy, the issue which will surely define Mr Bush's presidency. In foreign even more than domestic policy Mr Bush has shown an impressive ability to listen to advice, play hawks against doves, and push through his agenda with relentless determination. The real story is not Mr Rove's ability to pull the strings but Mr Bush's ability to pick and manage talented underlings, including supposed puppeteers like Mr Rove. ■

The birth of modern science

Give a dog a bad name

The Eye of the Lynx: Galileo, His Friends, and the Beginnings of Modern Natural History. By David Freedberg. *University of Chicago Press; 528 pages; \$50*

AS WITH events, so with ideas: the thread of historical development is in reality never broken, but following its course is often easier for us if we can spot (or invent) points where corners are turned, jumps made. David Freedberg, a professor of art history at Columbia University in New York and director of its Italian institute, invites us to focus on one such episode, centred in Italy during the first three decades of the 17th century and

involving the handful of scholars who formed themselves into the Academy of the Linceans—the first modern scientific academy. Their institutional title carried twin allusions to Lyncaeus, the most keen-eyed of the Argonauts, and to the lynx, credited with the most acute vision in the animal kingdom.

This is very much Freedberg territory. He is well known in the art-historical world for a widely discussed earlier book, "The Power of Images" (1989), which urged the profession to look harder at how pictures affect us emotionally and how that responsiveness shapes the uses we put them to—in law, politics and religion, for example. A historical essay on vision and science feels a natural continuation.

The evidence of their own eyes formed the principal currency of the Linceans' researches and they rejected all canonical wisdom that ran counter to what they could see and record. The first of these credos placed them in the vanguard of the empirical approach to scientific method (Francis Bacon was formulating his own philosophy, which enshrined similar principles, at this same moment in England). Their challenge to received authority led them into hazardous territory guarded by conservatives in the Catholic church.

That conflict is epitomised in the researches of Galileo, most famous of the Linceans. When Galileo trained his new-fangled telescope on the heavens, the edifice of Aristotelian cosmology, embraced by the church as a matter of faith, began to crumble: the incorruptible crystal spheres held to enclose the universe with the earth at its centre gave way to a model that was both dynamic and heliocentric. The support of the Lincean academy was crucial to Galileo during his most productive years, when he benefited too from the indulgence of Pope Urban VIII and his nephew

Cardinal Francesco Barberini—himself elected a Lincean. The eventual withdrawal of support from the Barberini clan proved catastrophic to Galileo and it was his erstwhile protector, Urban VIII, who sent him to the Inquisition.

The moving spirit behind the Lincean academy, however, was not Galileo but Federico Cesi, an enlightened nobleman who provided not only intellectual impetus but also financial support, above all in the field of natural history. His ambitions, never modest, centred on a scheme to reduce description of the entire natural world to tabular form. Before arriving at this extreme reductionism, Cesi and his circle had originally launched quite a different exercise—a project to record nature's variety in pictures.

There are many remarkable features to the thousands of illustrations the Linceans amassed (partly surviving in the Royal Collection at Windsor), including the earliest records of numerous plant species and the first graphic representations of observations by microscope—as revolutionary a development as Galileo's use of the telescope. Indeed, thanks partly to the newly invented microscope, the Linceans abandoned their attempt at an encyclopedic pictorial record when they saw that nature's complexities would have to be explained by appeal to inner structures, not by cataloguing arbitrary variations in external form and colour.

The evidence of the testicles

Other hallowed systems of belief were to fall before this new insistence on objective classification. Physiognomy and phytognomy, for example, by which plants and animals had assigned to them particular powers or properties on the basis of resemblance to various parts of the human body, were soon revealed in all their inadequacy. New scrutiny was turned too on whole swathes of nomenclature that enshrined such pretended resemblances—encapsulated most memorably in the plant graced by the name of *Testicoli di cane*—the dog's bollocks.

Wholehearted approval was surely richly earned by the Linceans themselves, and Mr Freedberg is persuasive in his advocacy of their pioneering work. He never goes so far as to become their eulogist, however, and sympathetically acknowledges their shortcomings as well as their triumphs. Often they found themselves simply overwhelmed by the scale of the task they had set themselves. Demolishing one world order was work enough, but replacing it by another, based on numbers, proved hugely more demanding.

Mr Freedberg has also tackled an enormous task in digesting the contents and implications of the publications, drawings, notebooks and correspondence of the Linceans, much of it in Latin or Italian,
