Iraq Opinion Data Summary: ABC News and CNN/Time
September 8, 2003

ABC News surveyed 1,004 adults September 4-7, and CNN/Time surveyed 1,003 adults September 3-4. Note that both surveys were completed before the President's September 7 address.

- CNN/Time finds Americans think the U.S. was right to go to war with Iraq by a 63% to 32% margin, a slight improvement from mid July's 61% to 35% margin.
- 71% tell CNN/Time the U.S. has done a good job in Iraq since major fighting ended, virtually unchanged since mid July. 53% say the military campaign has been neither successful nor unsuccessful, up from 46% in July. The percentage deeming it a success declined from 39% to 32%, but the percentage deeming it unsuccessful held steady at just 13%.
- By a 49% to 43% margin, Americans tell CNN/Time that the war was worth its toll in American lives and other costs, virtually unchanged since July.
- While CNN/Time found many of these measures unchanged from July, according to ABC, approval of the President's handling of the Iraq situation declined from a 56% to 37% margin in August to a 49% to 47% margin now.
- ABC finds Americans approve of the President's handling of terrorism by a 67% to 28% margin, down from a 79% to 19% margin in April.
- Matching the approval percentage, 67% tell ABC the U.S. is safer from terrorism today than it was before September 11. And 69% say the U.S. campaign against terrorism is going well, strong but down from 83% in April.
- The U.S. armed forces (92%) and the people of New York City (92%) receive the highest ratings for having done an excellent or good job responding to the events of September 11. 55% tell ABC the Bush Administration has done an excellent or good job.
- ABC finds Americans give the U.S. high marks for preventing further terrorist attacks (80% excellent/good), reorganizing government agencies to improve anti-terrorism efforts (70% excellent/good), improving U.S. intelligence gathering (65% excellent/good), and breaking up al Qaeda (60% excellent/good). Americans give a lower rating to U.S. efforts to win cooperation from other countries in fighting terrorism (42% excellent/good).

St. Patrick, Martyr

Republican Congressman Pat Toomey just finished a disastrous week. He might be the first man in Pennsylvania history to transform a bus tour into a train wreck. But Toomey isn't worried; he says his senate primary challenge to fellow Republican Arlen Specter is going just as he wants it to.

True, his 21-county, four-day, "Conservative Alternative" bus tour attracted more reporters than supporters. True, the tour's failure to spark the slightest bit of excitement prompted even the irony-challenged Associated Press to quip: "In the six months since he launched his U.S. Senate campaign, Rep. Pat Toomey has been quietly working to amass support. Maybe too quietly."

But don't be fooled. The bus fiasco was merely part of a brilliant master plan, Toomey told reporters over the weekend. When the Pittsburgh Tribune-Review asked if the lack of "big, cheering crowds, the kind that can signal political victory," disappointed his campaign staff, Toomey replied: "No, not disappointed at all. This is exactly what we expected. We're raising awareness. We're talking to members of the media."

That was news to members of the media - and anybody else who read the Aug. 21 press release heralding the bus tour. In it, the campaign announced Toomey was rolling across the state "to communicate to Republican voters his vision of lower taxes, less government and more personal freedom, which contrasts sharply with the career liberal record of Senator Arlen Specter." Toomey added that, to date, "The reception I have received has been overwhelming."

Indeed it has been. Reporters overwhelmed supporters during Toomey stops in Bucks, Chester and Montgomery counties, according to wire service and local newspaper accounts. Nobody at all greeted the campaign at Media's Delaware County courthouse - home turf to an Irish-Catholic political machine that would have been in Toomey's pocket already if he had a snowball's chance of winning.

In Carlisle, a county seat nestled firmly within the conservative "T," only about a dozen supporters who weren't affiliated with the campaign showed up to greet Toomey, the Patriot-News reported. And Toomey's reception was similarly dismal in the West. He attracted almost no attention Saturday at the Westmoreland County Fair.

"In fact, things were so low-key nary a fair-goer stirred as the candidate himself hoisted his two children, ages 3 and 2, onto 'Animal Train,' a miniature rail-go-round," wrote the Tribune-Review's Richard Robbins. "Pat Toomey might have just as well been Mr. Any Dad, not the man who is aiming to unseat a four-term Senate incumbent in what promises to be a bruising fight ..."

But, again, as Toomey told The AP at a desolate Delaware County courthouse: "We didn't set out to try to have big crowds .. That wasn't the goal. The goal was to get to every (media) market that we could get to, get to as many counties as we could visit, speak to members of the press there, meet with

some activists here and there."

At first, Toomey's insistence that his bus tour did what it set out to do sounded like face-saving hogwash. It's belied by the campaign's widely distributed statement of purpose in advance of the tour. It's also belied by the symbolic power of campaign buses ever since Ed Rendell used them to wallop Bob Casey Jr. in the 2002 gubernatorial primary.

When Pennsylvania reporters hear about a bus tour - particularly in a high-profile primary - they expect to see an energetic road show that ignites grassroots excitement in the hinterlands. Consequently, post-Rendell bus tours draw reporters. Toomey's handlers obviously knew that, but they didn't understand that bus tours also draw Rendell-esque expectations. They didn't grasp that Pennsylvania reporters would dismiss a bus-bound pol who wasn't greeted like a rock star. Pat Toomey was greeted like an Amway salesman.

Reporters also grasped the long-term significance of Toomey's grassroots weakness. As of June 30, Specter out raised Toomey by a margin of almost 6:1. If that disparity remains the same or widens, Specter will clobber Toomey with television ads. Toomey's only hope is to make early inroads with a network of rock-ribbed conservative supporters who can get out the vote. Last weekend's bus tour suggests that he certainly can't call upon that network now and probably can't call upon it in the future.

That's a daunting prospect for conservative donors. They want their fund-raising bucks to go where they'll do the most good. If Toomey looks like a bad investment, money from ideologically motivated sources will dry up. Unfortunately for Toomey, the "Conservative Alternative" tour may have downgraded his senate bid to a junk-grade risk.

Stephen Moore, president of the conservative Club for Growth and an enthusiastic Toomey admirer, expressed serious doubts this weekend as to whether his candidate can corral the conservative support he needs to win.

"The whole ball game is really whether or not Toomey can get the voters of Pennsylvania, outside of Allentown, to know that he's a strong conservative," Moore told AP reporter Lara Jakes Jordan. "It's going to take heavy TV advertising and radio advertising - that's the only way he can do it. He can't do that with bus tours."

He also can't win by compulsively courting double-edged coverage. The bus tour did just that. It raised awareness of Toomey's campaign just enough for the press to notice that his grassroots support was tissue-thin. There are other examples:

Last week's National Review cover story pronounced a conservative anathema on Specter. But it also prompted a generation of GOP senate leaders - Howard Baker, Bob Dole, Trent Lott and Bill Frist - to voice unqualified, unprecedented support for Specter's reelection.

Several months ago, A Wall Street Journal Op-Ed piece blasted Specter and praised Toomey. But the piece forfeited credibility when it suggested White House support for Specter was weak and perfunctory. Days after it appeared, White House Chief of Staff Andrew Card and Vice President Dick Cheney announced a major fund-raising stop in Allentown. The White House has been stumping for Specter ever since.

Whenever Toomey touts his high American Conservative Union career rating (94 out of 100), he draws attention to ACU Chairman David Keene's endorsement of Specter.

When he pitches himself as Pennsylvania's conservative alternative, Toomey inadvertently reminds people that the state's most visible right-wing icon, Rick Santorum, supports Specter.

And although he has tried, Toomey can't run credibly as an outsider. Efforts

to brand Specter an "establishment" candidate remind people that the same establishment elected Pat Toomey - a white, Christian, Harvard-educated, Republican businessman - to membership in the U.S. House. Since when does a guy from an exclusive club get away with calling a guy in another exclusive club an elitist?

Still, despite all of his message backfires, now underscored by an infamous bus tour, Toomey maintains his campaign is doing exactly what it always had planned to do.

Maybe Toomey plans to lose. If that sounds flip, it isn't meant to. Right-wing Republicans have a long tradition of self-righteous immolation in Pennsylvania. They turn down congressional pork, even though liberals and moderates are thrilled to feast on whatever conservative ideologues leave at the budget table. They back third-party candidates who weaken the very Republican Party movement conservatives hope to commandeer.

They also favor term limits, which cede seniority and open seats to liberals and moderates. That's certainly true in Toomey's case. At the moment it appears his Lehigh Valley congressional seat will go either to a pro-choice Republican or to a Democrat. If he loses the senate primary - a possibility his strongest supporters deem likely - Toomey will have cost conservatives a modestly senior Republican vote in the House. He will have gained them nothing in the Senate - save a needlessly expensive primary.

It's an irrefutable fact that time after time, Toomey and many of his campaign intimates have preferred no loaf to half-a-loaf. So the notion that he might embrace ideological martyrdom is neither disrespectful nor far-fetched. Perhaps Toomey doesn't want to be Rick Santorum; maybe he wants to be Steve Freind. Maybe his sang-froid on the hustings is more than just a PR fig leaf; he really might not care whether he can beat Specter. His conservative message could be an end in itself.

Either way, the bus tour raises a legitimate question: Is Pat Toomey a conservative candidate or a conservative martyr? We'll know the answer if he charters another bus.

The directors and executive officers of Belo Corp. have watched with astonishment as Republicans have joined with Democrats in attempting to reverse the Federal Communications Commission's June 2 rulemaking on media ownership. We urge you to veto any legislation that includes provisions that compromise part or all of the FCC rulemaking.

Belo has followed the rulemaking process closely over the past year, and we have participated by making filings as appropriate and supporting Chairman Powell's leadership. The June 2 rulemaking makes moderate revisions to ownership rules which were, in some cases, more than 25 years old and bore no relationship to the current media marketplace. The Commission's decision is completely consistent with the market-driven approach that you have continually advanced as President and, before that, as our Governor. 

STATEMENT OF ADMINISTRATION POLICY (THIS

Departments of Commerce, Justice, and State, the Judiciary, and Related Agencies

Appropriations Bill, FY 2004

(Sponsors: Young (R), Florida; Obey (D), Wisconsin)

The Administration supports House passage of the FY 2004 Commerce, Justice, and State Appropriations Bill. The Administration appreciates the Committee's support for the programs and initiatives of the Department of Justice, including the requested increases for Federal law enforcement and the President's DNA initiative. However, the Administration has several specific concerns with the House bill and will work with the Congress on these and other issues as the bill moves through the legislative process.

Specifically, the bill contains a provision blocking implementation of a Federal Communications Commission (FCC) rule establishing a new national television ownership cap. The Administration believes that the new FCC media ownership rules more accurately reflect the changing media landscape and the current state of network station ownership, while still guarding against undue concentration in the marketplace. If this provision or a provision like it with respect to any one of the other FCC Rules is contained in the final legislation presented to the President, his Senior Advisors would recommend that he veto the bill.

The Administration applauds the Committee for reporting this bill in a timely manner and looks forward to working with the Congress to ensure that the FY 2004 appropriations bills ultimately fit within the top line funding level agreed to by both the Administration and the Congress. The President supports a discretionary spending total of

\$784.7 billion, along with advance appropriations of \$23.2 billion for FY 2005 – in accordance with his Budget and the FY 2004 Congressional Budget Resolution. Only within such a fiscal environment can we encourage increased economic growth and a return to a balanced budget. The Administration looks forward to working with the Congress to ensure that its priorities are met within that overall total.

Additional Administration views regarding the Committee's version of the bill are:

Citizen Corps

The Administration urges the House to provide full funding for the Citizen Corps initiative, a Presidential priority and component of the USA Freedom Corps. This important initiative will make communities safer, stronger, and better prepared to respond to the threats of terrorism, crime, public health issues, and disasters of all kinds.

Department of Commerce (DOC)

The Administration appreciates the full funding of Census Bureau programs, the Administration urges the House to restore the \$10 million reduction from the President's request of \$85 million for the Economic and Statistics Administration. The requested funding will support initiatives of the Bureau of Economic Analysis to accelerate the release and improve the accuracy of key economic indicators, including the Gross Domestic Product. The Administration is also concerned that the reduced funding for the National Oceanic and Atmospheric Administration (NOAA) will impair NOAA's ability to manage the Nation's commercial fisheries.

The Administration is disappointed that the bill does not provide sufficient funds for the Patent and Trademark Office to adequately improve patent and trademark quality, reduce pendency, and make operations fully electronic. The Administration urges the Congress to support the associated fee reform legislation, which will provide the additional fee revenue needed to support these operational improvements. The

Administration also encourages the House to restore the reduction from the President's request for Commerce's Departmental Management, in order to fund E-Government initiatives, information technology security and critical infrastructure protection, and renovation planning for the Herbert Hoover building.

The Administration appreciates the Committee's efforts to reduce spending that is no longer warranted or is of an insufficiently high priority. Additional savings could be realized through adoption of the Administration's proposed rescission of unobligated steel loan guarantee funds and termination of the Technology Opportunities Program.

Department of Justice (DOJ)

The Administration urges the House to fully fund the President's request for the drug court program, which diverts non-violent drug offenders into treatment and brings nearly half of them to successful completion of treatment.

The Administration appreciates the Committee's full funding for the Organized Crime Drug Enforcement Task Force (OCDETF). However, the Administration opposes the merger of the OCDETF program into the Drug Enforcement Administration (DEA). The Administration believes that OCDETF management should continue under the direction of the Office of the Deputy Attorney General to ensure that program management and resource allocation decisions are objective and not made by one stakeholder. The Administration also appreciates the Committee's support for the efforts to enhance drug intelligence capabilities. However, the Administration believes that placing this capability under OCDETF, rather than DEA, will help to ensure objectivity and multi-agency participation in decision-making.

The Committee bill did not include the Administration's budget restructuring efforts. This restructuring would provide the Administration and the Congress a more performance-based budget that is linked to mission and outcomes.

The Administration also encourages the House to adopt the proposed rescission of \$188 million from the Bureau of Prisons prior-year construction funds, which is intended to encourage the consideration of alternatives to prison construction, including the use of available private, State, and local prison bed-space and facilities.

Department of State

The Administration appreciates that the bill funds many programs at the requested levels and consolidates educational and cultural exchange programs. The Administration opposes the following reductions from the request: \$63 million from the Diplomatic and Consular Programs account, which would reduce the resources and personnel necessary to carry out its mission and funding for the G-8 summit to be held in the United States during 2004; \$120 million from Embassy Security, Construction and Maintenance account for the new embassy building in Berlin that has been in planning for over a decade; and reductions to a number of smaller organizations and commissions. In addition, the bill contains several problematic earmarks within the Diplomatic and Consular Programs account. The Administration is also concerned about a provision that delays the obligation of \$84 million in the Capital Investment Fund until September 2004, prohibiting the State Department from purchasing basic information technology infrastructure for a year.

Equal Employment Opportunity Commission (EEOC)

The Administration is disappointed that the Committee provided only \$328 million for EEOC, \$6 million below the President's request. At this level, it will be difficult for EEOC to maintain reductions in its private-sector complaints inventory, and the agency may have to postpone key management reforms that will allow it to serve citizens more efficiently. The Administration urges the House to provide the full request.

United States Trade Representative (USTR)

The Administration is concerned with the additional funding provided to USTR, \$5 million more than the request. The unrequested earmark of \$2 million for enforcement and monitoring of China's trade commitments is unnecessary.

Infringements on Executive Authority

The Administration objects to Section 609 in the bill, which would restrict the use of funds for U.N. peacekeeping missions that involve U.S. Armed Forces under the command or control of a foreign national, places unconstitutional conditions on the President's authority to command the armed

forces. In addition, Section 610, which would preclude the use of funds to maintain diplomatic relations with Vietnam unless the President certifies to Congress that Vietnam has satisfied specific conditions mandated by Congress, is an unconstitutional condition on the exercise of the President's power to control the recognition and non-recognition of foreign governments.
