BIOGRAPHIES OF PARTICIPANTS

James Dobson, Founder and Chairman, Focus on the Family

Dr. James C. Dobson, Ph.D., is founder and Chairman of the Board of Focus on the Family, a nonprofit organization that produces his internationally syndicated radio programs. His programs are heard daily on more than 3,000 radio facilities in North America and in 15 languages on approximately 3,300 facilities in over 116 other countries. His commentaries are heard by more than 200 million people every day, including a program translation carried on all State-owned radio stations in the People's Republic of China. He is seen on 80 television stations daily in the United States. For 14 years, Dr. Dobson was an Associate Clinical Professor of Pediatrics at the University of Southern California School of Medicine, and served for 17 years on the Attending Staff of Children's Hospital of Los Angeles in the Division of Child Development and Medical Genetics.

Don Hodel, President, Focus on the Family

Effective May 15, 2003, Don Hodel became President and CEO of Focus on the Family in an effort to enable Dr. Dobson to concentrate on being the chief spokesman of the ministry. Mr. Hodel served in the Reagan administration for eight years. He was appointed successively as Under Secretary of the Interior (1981-1982), Secretary of the Department of Energy (1982-1985), and Secretary of the Interior (1985-1989). In January of 1989, President Reagan awarded Mr. Hodel the Presidential Citizens Medal. Prior to joining the President's cabinet, Mr. Hodel and his wife, Barbara, formed their own energy consulting firm. He previously served as Administrator of the Bonneville Power Administration.

Chuck Colson, Founder, Prison Fellowship

In 1976, Chuck Colson founded Prison Fellowship Ministries, which, in collaboration with churches of all confessions and denominations, has become the world's largest outreach to prisoners, ex-prisoners, crime victims, and their families. Colson has spent the last 25 years as head of Prison Fellowship Ministries. He has visited prisons throughout the U.S. and the world and has built a movement working with more than 40,000 prison ministry volunteers with ministries in 100 countries. In 1991, Colson launched a daily radio feature called *BreakPoint* in an attempt to provide a distinct Christian worldview on everyday issues and conflicts. The program is aired daily on over 1,000 radio outlets nationwide. His 1987 book, *Kingdoms in Conflict*, was a best-selling directive to the Christian community on the proper relationships of church and state.

Tony Perkins, President, Family Research Council

Tony Perkins has been President of the Family Research Council's (FRC) Board of Directors since September 1, 2003. Prior to joining FRC, Perkins served two terms in the Louisiana House of Representatives, where he was the leading opponent of Louisiana's gambling industry and one of the State's most vocal pro-life advocates. He is a veteran of the United States Marine Corps and a former police officer.

Mike Farris, Chairman and General Counsel, Home School Legal Defense Association

Michael Farris is Chairman and General Counsel of the Home School Legal Defense Association, which he founded in 1983. He is a lawyer whose practice focuses on constitutional issues, one of the leading pro-family activists on Capitol Hill, an author, and an ordained minister. He is also President and Professor of Government at Patrick Henry College in

Purcellville, Virginia. He has argued in front of the United States Supreme Court, five U.S. circuit courts of appeal, seven state supreme courts, and five state courts of appeal. Farris was ordained into the ministry in 1983, and in 1993, he was the Republican nominee for Lieutenant Governor of Virginia. BIOGRAPHIES OF PARTICIPANTS

Jack Graham, President, Southern Baptist Convention

Dr. Jack Graham is Senior Pastor of Prestonwood Baptist Church in Dallas, Texas, one of America's largest congregations, with a membership of more than 21,000 people. He has served as a pastor in churches in Texas, Oklahoma, and Florida. In addition to Prestonwood, Pastor Jack Graham serves on the executive committee and as President of the Southern Baptist Convention (SBC), an association of some 40,000 independent churches.

Richard Land, President, Ethics and Religious Liberty Commission

Dr. Richard Land has served as president of the Southern Baptist Convention's Ethics and Religious Liberty Commission since 1988. In August 2003, you reappointed Dr. Land to a second term on the United States Commission on International Religious Freedom. As host of *For Faith and Family* and *For Faith and Family's Insight*, two nationally syndicated radio programs, Dr. Land speaks on social, ethical, and public policy issues facing our country. The *For Faith and Family* broadcast ministry is heard by more than 1.5 million listeners each week on nearly 600 radio stations across the country and throughout the world on the Internet. *Richard Land Live!* is Dr. Land's latest radio initiative. The program is a live, three-hour, caller-driven weekend program that is syndicated on the Salem Radio Network.

Frank Wright, President, National Religious Broadcasters

Dr. Frank Wright is president of the National Religious Broadcasters (NRB), an international association of Christian communicators with more than 1,600 members, representing millions of viewers, listeners, and readers. As an ordained elder in the Presbyterian Church (PCA), Dr. Wright has a long history of involvement in Christian ministry, including a 20-year association with the ministries of Dr. D. James Kennedy. Prior to assuming the presidency of NRB, Dr. Wright served as founding executive director of the Center for Christian Statesmanship, a spiritually-based effort to reach out to members of Congress and their staff. As part of the executive staff of Coral Ridge Ministries, Dr. Wright also served on the program planning team for the *Truths That Transform* radio broadcast and *The Coral Ridge Hour* television program.

Adrian Rogers, former three-term president, Southern Baptist Convention

Dr. Adrian Rogers is the Pastor of Bellevue Baptist Church and one of America's most respected Bible preachers. Under his pastoral leadership, Bellevue Baptist Church in Memphis, Tennessee, has grown from 9,000 members in 1972 to more than 27,000 today. A staunch defender of Biblical inerrancy, Pastor Rogers has been called upon to serve three times as president of the 14-million member Southern Baptist Convention. Dr. Rogers is also the pastor/teacher of *Love Worth Finding*, a radio and television ministry that Dr. Rogers' message in four languages to more than 14,000 television outlets and 1,100 radio outlets in the United States and 150 other countries including all of Europe, Latin America, China, Australia, Africa, and India.

Ted Haggard, President, National Association of Evangelicals

Ted Haggard serves as the President of the National Association of Evangelicals, the largest evangelical group in America representing over 22 million evangelical Christians. He founded New Life Church in Colorado Springs in 1985, where he serves as Senior Pastor. The church now has over 10,000 members and is the largest church in Colorado. Haggard also formed and

serves as President of the Association of Life Giving Churches, a network committed to the development of strong, healthy local churches, and is President of the World Prayer Center and its Internet ministry, worldprayerteam.org.

Janet Parshall, Host, *Janet Parshall's America*

Janet Parshall is the host of *Janet Parshall's America*, a three-hour, nationally syndicated program. *Janet Parshall's America* is one of the only conservative talk shows in America hosted by a woman. Professor Kolakowski, who now resides in Oxford, England, was born in Radom, Poland, in 1927. He is a European philosopher, historian, and essayist, having written more than thirty books and 400 other writings in a variety of formats and in four languages: primarily in Polish, but also in French, English, and German. He writes principally about the history of philosophy and the philosophy of religion.

When he was ten-years-old, Kolakowski's family moved to Łódź, Poland, where he lived under German occupation during the Second World War. He did not attend school, but read books and had occasional private lessons in the underground school system. He eventually studied philosophy at Warsaw University, where he earned his doctorate in 1953, later becoming a professor and chairman of its section on the history of philosophy from 1959-68. An orthodox Marxist at first, he was sent by the party to Moscow in 1950 to study the Stalinist system. Disillusioned with the stagnation of Communism, he became increasingly outspoken. He was expelled from the party in 1966, dismissed from his professorship two years later, and went into exile. His works, appearing in underground editions, continued to shape the opinions of the Polish intellectual opposition. After leaving Poland, Kolakowski became a visiting professor in the department of philosophy at McGill University (1968-69), the University of California, Berkeley (1969-70), and a senior research fellow at All Souls College, Oxford (1970). Based in Oxford since 1970, he spent part of 1974 at Yale, and from 1981 to 1994, he was a part-time professor at the University of Chicago. He has been a fellow of scholarly societies in many countries and has received numerous academic honors and awards.

James H. Billington, Librarian of Congress

Dr. Billington was sworn in as the 13th Librarian of Congress on September 14, 1987. He earned his undergraduate degree from Princeton University and his doctorate from Oxford University, where he was a Rhodes Scholar.
