

Bush's 10-year, \$1.35 trillion tax cut last summer, the same crystal ball predicted whopping surpluses into the foreseeable future—arguing that tax cuts were long overdue and only a fraction of the projected \$5.6 trillion surplus. Two years after the Clinton-era bull market collapsed, the Treasury Department now estimates the tax shortfall at \$102.2 billion compared to last year. Even William Hoagland, GOP staff director of the prestigious Senate Budget Committee, projects that the Congressional Budget Office's \$46 billion deficit could double its size. "What's surprising is the order of the magnitude of the reduction not accounted for by the cut," said Hoagland, realizing that the Bush tax cut accounted for less than 50% of the expected shortfall, blaming the discrepancy on a sluggish economy—or maybe something more ominous. Pointing fingers at tax cuts, the recession and fiscal problems can't account for today's exploding deficits.

Every one-tenth percent rise in unemployment, adds \$10 billion to the budget deficit, with unemployment already rising 1.7% since March 2000, erasing a \$127 billion surplus and adding a hefty \$50 billion to government red ink. "During the late '90s, there was a series of favorable federal income tax surprises that pushed up revenues," said John Youngendahl, an economist with the New York investment bank Goldman Sachs. "What we're seeing is that these are now reversing," suggesting that the government's revenue stream—especially from the raging bull market—won't return anytime soon. While tax cuts are thought to be a stimulus to the economy, they're not a cure for a lifeless stock market facing reality after five years of bloated growth. Sure, recessions hurt the market by lowering corporate earnings, but they don't account for how inflated markets go bust. "If these trends continue, it's bad news for the budget, and not just this year," said Rep. John M. Spurr Jr. (D-S.C.), the ranking Democrat on the House Budget Committee, beginning to see that increases in the GDP won't replace the government's lost income.

While some finger Bush's tax plan as fiscally irresponsible, it had the backing of Fed Chairman Alan Greenspan—through Greenspan suggested that monetary policy would have a greater impact on the economy. When the economy stubbornly came out the recession in 1994, tax rates were still disproportionately high to compensate for high unemployment. By the mid-'90s, unemployment dropped and government receipts mushroomed, balancing the budget and, yes, eventually producing huge surpluses. But since the market crashed in Spring 2000, capital gains and income tax revenue dried up, leaving the government scrambling to pay its bills. Granting tax cuts were supposed to stimulate the economy, fuel consumer and capital spending, reduce unemployment and expand the tax base. While the latest GDP figures show the economy growing at 5.8%, it doesn't undo the stock market's malaise. Even if the economy expands adding new jobs, it won't automatically make up the revenue lost when the market went south.

Forced to borrow from Social Security, the White House now faces tough times. As Greenspan found out, lowering interest rates can't provide enough stimulus to spur capital spending, especially when corporations face dismal earnings. Since copious market capitalization is no longer available, few corporations have enough cash to expand. Without new investment, corporations are not in a position to acquire new businesses or turn a profit. Since the Enron mess, creative accounting, to keep debts off the books and profits high, can't hide companies' poor profitability. With the stock market down, market capitalization can't bail out businesses still in the process of developing profitability. Quite simply, when the market tanked, many businesses—new economy and old—could no longer pay their bills without selling stock. Even established businesses have difficulty maintaining bond ratings, when analysts can't see earnings close by. With most new economy businesses unable to pull their weight without selling stock, it's difficult to imagine hefty earnings anytime soon.

What comes up must come down. Before the bubble burst in March 2000, analysts warned that price-earnings ratios were disproportionately high, triggering the most massive exodus out of stocks since the great depression. Mutual fund outflows reached a critical mass in mid-2001, pulling the plug on long-term investing. To make matters worse, Sept. 11 drove remaining investors into cash, further dropping the DOW and Nasdaq to recent lows. For the next several months, markets rebounded, hit stubborn resistance, and moved sideways testing new lows. Regressing to the mean, markets began to regain affordability, dropping inflated multiples and share prices over 50%. Now comes the dilemma. With far fewer equity investors having faith in the market, it's difficult to expect a return to the kind of momentum seen before the bubble burst in March 2000. With multiples reduced, less investors in the market, and stocks stuck in reverse, it's unrealistic to expect the capital infusion needed to create the next bull market. Given this scenario, the government expects far less capital gains revenue, leaving deficits into the foreseeable future.

Now comes the hard part. Faced with ballooning deficits, the government can't continue to borrow indefinitely from Medicare and Social Security. Either the government will be forced to live with growing deficits, cut government spending or raise taxes, placing Bush's \$1.35 trillion tax cut in jeopardy. While it's true that tax cuts have historically provided economic stimulus, they can't replace the whopping capital gains lost when the market melted down. Few economists predict a return to unprecedented windfalls of the late '90s. Heading into mid-term elections, the White House isn't likely to advocate sweeping cuts in government spending. Right now budget deficits will be tolerated as a necessary evil to allow the current economic recovery to keep going. But once deficits force the government to borrow from private capital markets and raise the national debt, it will put upward pressure on interest rates and threaten a fragile recovery. Alan Greenspan is running out of tricks. Eventually, the government will be forced to live within its means. With surpluses now a fading memory, it's time to face reality and stop juggling the books.

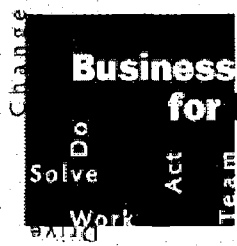

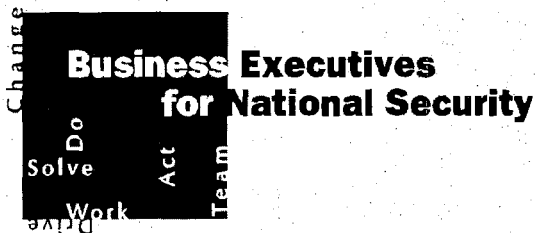

Talking Points for the American Society of Anesthesiologists

May 1, 2002

Medicare

- As you know, Medicare needs to be modernized. Too much of your practice depends on payment formulas that have to be legislated by Congress, and on regulations that are often set by bureaucrats.
- It's gotten to the point where giving control and responsibility to doctors and patients is almost a radical idea.
- We've tried to do what we can administratively. We modified a leftover Clinton administration regulation that would have automatically changed the requirements for participation by anesthesiologists in patient care, in ways that could harm quality of care. We've tried to reduce regulatory burdens where we can, and to make it easier for you to get a response from the Medicare program for your concerns. We're looking at ways to improve physician payments through administrative actions. We want to hear from you about how we can do more.
- But we need legislation from Congress to make the improvements that Medicare really needs. Not just legislation that provides a prescription drug benefit in Medicare quickly, especially for those who most need help. We also need legislation to give seniors and doctors more choices than just the government-run plan – so that they can get better benefits and fairer payments. And we need legislation to address unfair reductions in physician payment.
- We appreciate your support of the President's goal of legislation that modernizes Medicare, so that we can have a program that is competitive and that provides real choices – one that doesn't depend on tightly regulating doctor prices to make ends meet.

In case they press you on the "negative update" for physician payment in the government Medicare plan this year, or if you want to be more aggressive on this, you could add the following:

- The Administration believes that the problems with the physician payment update need to be addressed. We think this should be done in the context of putting all of Medicare provider payments on the table – so that physicians aren't subjected to far more stringent payment rules than other providers.
- But a basic truth of Medicare throughout the last 30 years is that anytime money is tight, providers get squeezed. And unless we enact legislation soon that modernizes Medicare so that the program doesn't depend so much on regulating prices to keep costs down, it's just going to get worse.

Patients' Bill of Rights

- The President, as you know, has been working hard to pass a Patients' Bill of Rights.
- We think that we're closer to getting a Patients' Bill of Rights today than at any time in this long debate. The ASA has been an active participant for many years in the fight to pass managed care reform. Much to your credit, both the House and Senate bills contain identical, strong patient protections and appeals processes that will increase patients' access to care.
- The only provisions preventing the President from signing a bill are those affecting liability. As you may know, the House bill includes a cap on non-economic damages, the Senate bill does not. The President has made it clear he wants to grant Americans meaningful legal remedies when they have been harmed by their HMO. But he will not allow unlimited damages that will unnecessarily drive up the costs of health care and cause Americans to lose their health coverage.
- Frankly, the cap issue is one on which we could use support from the medical profession. We all understand why trial lawyers will continue to insist on unlimited liability, but the medical profession should be just as vocal on insisting that the Senate pass a Patients' Bill of Rights -- with a cap on non-economic damages -- so that the President can sign this bill into law.

Bioterrorism

- The President and Director Ridge (Homeland Security) are working hard to ensure we are prepared if we are ever unfortunately subject to a bioterrorist attack. We want to work closely with the medical profession such as the ASA, who will be on the front lines of responding to such an attack.
- The President has included nearly \$5.9 billion dollars in his FY 2003 request for bioterrorism-related activities.
- The Administration sent legislative proposals to Congress last October that are included in the bioterrorism bills that are currently in a House and Senate conference. The legislation includes: 1) funding to expand the National Pharmaceutical Stockpile and to provide grants to states, localities, and health care facilities to respond to a bioterrorist attack; 2) enhanced authorities for HHS to improve food safety and security; and 3) increased regulation of biological agents and toxins that pose a threat to public health.
- The President hopes Congress will conclude the conference quickly to provide the Administration with these expanded authorities as soon as possible.

Dear Senators Feinstein and Boxer:

Thank you for your April 17 letter about the judicial vacancy crisis in the Ninth Circuit. Thank you also for forwarding the names of three candidates for the Ninth Circuit. We had already begun evaluating those individuals, as well as several others.

I share your concern about "a Circuit already facing heavy caseloads and complex appeals." As you know, three Ninth Circuit vacancies have existed since President Bush took office (two slated for California and one for Hawaii). A fourth vacancy occurred this year (slated for Nevada). All of the current Ninth Circuit vacancies have been classified as "judicial emergencies" by the Judicial Conference of the United States.

I appreciate your informing me of the impending fifth vacancy in the Ninth Circuit due to Judge Fernandez's retirement (again slated for California). This will leave the Ninth Circuit with only 23 active judges on a 28-judge court. And the workload crisis on the court is even more serious than the numbers reflect. The Judicial Conference has asked for two new permanent and three temporary judges on the Ninth Circuit to help cope with the caseload -- thus, a total of 33 that are needed according to the Judicial Conference. In light of the Judicial Conference's proposals, the Ninth Circuit needs a nearly 50% increase in the number of active judges.

The President has responded to the Ninth Circuit vacancy crisis in the same decisive manner that he has responded to the national judicial vacancy crisis. Nearly a year ago, he submitted two nominations, Judge Carolyn Kuhl of California and Richard Clifton of Hawaii. For the new vacancy slated for Nevada, following our consultations with Senators Reid and Ensign, the President soon will be moving forward on an excellent nominee. We also had discussed with you last year a fourth potential Ninth Circuit nominee, Congressman Chris Cox of California. Finally, the President also intends to move forward expeditiously on the vacancy created by Judge Fernandez's retirement.

Despite the crisis in the Ninth Circuit, President Bush's pending nominees for that Circuit -- Judge Kuhl and Mr. Clifton -- have now waited more than 10 months for hearings before the Senate Judiciary Committee. The delay has occurred notwithstanding the fact that Judge Kuhl and Mr. Clifton, like all of the President's circuit court nominees, are mainstream candidates with superb qualifications, experience, character, and integrity. Indeed, Judge Kuhl received a well-qualified rating and Mr. Clifton a qualified rating from the American Bar Association. A year ago, as you know, Senators Leahy and Schumer referred to the ABA rating as the "gold standard" for evaluating judicial nominees.

Because Judge Kuhl is a pending nominee from your State, we respectfully request that Senator Boxer return the "blue slip" as Senator Feinstein has done and that you both ask Chairman Leahy to schedule a hearing and vote for Judge Kuhl. Judge Kuhl is particularly deserving of your support, in my judgment, given her extensive experience in federal and state government, in the Executive and Judicial Branches, in public service and private legal practice. She is a woman of character and accomplishment. Judge Kuhl has a combination of intellect, experience, and character that makes her ideally suited to be an excellent circuit judge.

Given her record, it is no surprise that Judge Kuhl has garnered bipartisan support from California and national leaders. Those supporters include people you know well: Vilma Martinez, who is an accomplished and nationally respected California attorney and is a past President of the Mexican American Legal Defense and Education Fund; Walter Dellinger, who was head of the Office of Legal Counsel and Acting Solicitor General under President Clinton; Ron Olson, who is a renowned attorney and partner at Munger Tolles & Olson in Los Angeles; and Rex Heinke, President of the Los Angeles County Bar Association.

We understand that certain special interest groups have raised questions about Judge Kuhl -- particularly her position on abortion rights. We do not know Judge Kuhl's policy views or moral views on abortion. As I advised Senator Feinstein, we do not ask nominees their personal views on this issue. But regardless of what her views are, we are confident that she would faithfully apply precedent as a circuit judge. Indeed, in the questionnaire she submitted to you last year, Judge Kuhl wrote as follows:

The constitutional right of a woman to make her own choices regarding personal medical issues, including choices regarding issues of reproductive freedom, has been established by both *Roe v. Wade* and *Planned Parenthood v. Casey* [citations omitted]. As a judge I am fully committed to following the precedent established by these cases and would do so fairly and properly. As I told you in our meeting and told Senator Feinstein in my meeting with her, as a judge I am and would be pro-choice in the sense that I am fully committed to following the state laws that protect a woman's right to have an abortion and Supreme Court precedent stating that a woman's right to choose to have an abortion is protected under the Constitution.

We believe that Judge Kuhl's statement fully and persuasively addresses any legitimate question whether she would follow precedent as a circuit judge.

The Senate's delay with respect to Judge Kuhl is especially unfortunate because Judge Kuhl took the extraordinary step in 1998 of writing to then-Chairman Hatch to support a hearing for Judge Richard Paez, one of President Clinton's nominees who had not received a prompt hearing and vote. This episode, of course, is just one of many examples in Judge Kuhl's career where she has shown herself to be concerned with law and process.

To the extent that there are additional issues regarding Judge Kuhl, we respectfully suggest that a hearing is the proper forum in which to air and address them. As the President stated last May 9, and as the Chief Justice requested "on behalf of the judiciary" in his annual report, all judicial nominees should receive a prompt hearing and vote in the Senate.

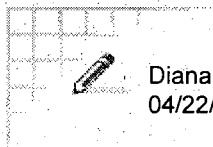

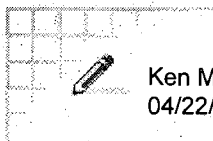

1. The President has repeatedly and consistently said that he does not support amnesty for illegal aliens. He has specifically told President Fox that he will not support a migration policy relating to Mexican nationals that involves amnesty.
2. The President inherited an INS that did not adequately enforce the immigration laws nor adequately deliver immigration services to qualified individuals. The Administration's INS reorganization plan was announced in November and Commissioner Ziglar is moving quickly on key steps to reform the agency.
3. The President has under consideration various plans for consolidation of agencies responsible for enforcement of border security laws. He and his staff are undertaking a careful review of the merits of these various proposals.
4. One of the highest priorities of Governor Ridge and the Office of Homeland Security is to ensure the safety of our borders. The President's Homeland Security Presidential Directive 2 described the policy of the U.S. to work aggressively to prevent aliens who engage in or support terrorist activity from entering the U.S. and to detain, prosecute, or deport any aliens who are within the U.S.
5. The INS (and the Department of Justice) have worked aggressively since September 11 to ensure the security of our borders. Attached is a document describing some of those many activities.

INS INITIATIVES TAKEN SINCE SEPTEMBER 11, 2001

GENERAL

- On September 11, all ports-of-entry (POEs) were placed on a Threat Level One status and continue in that status today; all POEs are now being staffed on a twenty-four hours a day, seven days per week basis. These actions were taken in conjunction with the United States Customs Service (USCS). Ports are operating under normal business hours and additional staff has been re-deployed to provide security when ports are normally closed and to augment existing staff during normal hours of operation.
- On September 11, the Immigration and Naturalization Service (INS) activated its Command Center, operating on a 24/7 basis. This stand-by Command Center with sophisticated communications equipment was utilized for two months after the terrorist attacks as the focal point for all INS operations.
- Within hours of the attack INS set up the Prevent Departure Unit under Section 215 of the INA. The 215 Unit was responsible for the rapid turnaround and dissemination of the Prevent Departure Lists that were based on the FBI's "Watch Lists." These lists went to all INS regional field offices, other federal government agencies, and transportation organizations.
- Immediately after the September 11 attacks, the INS suggested to the Attorney General that various federal law enforcement agencies, including the Border Patrol dispatch agents to airports to provide additional security. The Attorney General made this recommendation to the President and within 36 hours of the attacks INS deployed 317 Border Patrol agents to nine airports across the country as part of a multi-agency effort to heighten security and safeguard civilian passengers, employees and property at key airports in the United States. National Guard personnel replaced these agents on October 25.
- By September 14th, INS activated a specialized unit to coordinate the investigation and possible detention of individuals of interest to other law enforcement agencies.
- Over 100 Inspectors have been deployed to land border POEs to augment staff based on operational needs since September 11. Re-deployments are an ongoing process.
- To supplement resources available from the Inspections Program, 110 Border Patrol Agents were also deployed to northern border POEs. These agents assisted with traffic management, inspections and port security. In addition, 40 Border

Patrol Agents were detailed to the ports of San Ysidro and El Paso to assist with traffic management.

- INS immediately committed almost 1,000 Special Agents to support the FBI PENTTBOM investigation. This support continues and includes a 24-hour presence at the FBI Strategic Information Operations Center (SIOC) by INS investigators and attorneys.
- Progressive inspection of aircraft was suspended and all flights into the United States are now being inspected at their first U.S. port of arrival consistent with Threat Level One procedures.
- Throughout the emergency, INS Border Patrol worked with the U.S. Coast Guard to undertake a variety of initiatives to increase safety and security in the Great Lakes region. These include joint missions, intelligence sharing and the expanded use of the Integrated Marine Enforcement Team (IMET) concept. Initially, cooperative efforts focused on the Lower and Upper Niagara River, St. Clair River, St. Clair Lake, and the Sault St. Marie River.
- INS is reviewing the physical design of existing POE facilities in order to enhance both physical security and to better manage passenger flow. In addition, INS is determining whether some POEs should be eliminated or closed due to security concerns.
- In November, Attorney General Ashcroft and INS Commissioner Ziglar released the Administration's plan to reform and restructure the INS. The INS restructuring plan is a fundamental reform that splits service and enforcement into two bureaus. It will clarify and streamline the chain of command at INS and increase accountability. In late March, the Department of Justice received letters from the House and Senate Commerce, Justice, State Appropriations Subcommittees concurring in INS moving forward with the full restructuring plan. In April, the first steps in the restructuring, including establishing a direct reporting chain from Sector Chiefs to the Chief of the Border Patrol, were carried out.
- On December 5, INS announced the Alien Absconder Initiative. This project involves entering the names of fugitive alien absconders into the FBI's National Crime Information Center database.
- On January 14, the INS detailed 100 Border Patrol agents to strategic locations along the Northern border (Operation Northern Vigilance 2002) to enhance operational capabilities between the Ports of Entry.

- In February, the INS Border Patrol deployed 261 agents to the Winter Olympics to provide outer perimeter security at three (3) venue sites: Park City Main Street, Park City Ski Venue, and Deer Valley, Utah. Outer perimeter coverage was provided 24 hours a day, 7 days per week for the duration of the events. The Border Patrol worked closely with the Secret Service and a number of other agencies to provide security.
- On February 15, 2002, INS signed a Memorandum of Agreement with the Department of Defense (DoD) for limited POE and Border Patrol support in order to sustain Threat Level One anti-terrorism operations. Extended discussions with DoD have resulted in an agreement that DoD will supply 16 intelligence personnel, to work in sector intelligence centers, and 6 helicopters, to provide aviation support in six sectors. In addition, DoD has agreed to supply personnel to land border POEs to provide a heightened security presence, assist in physical inspection of vehicles, and perform traffic management and pedestrian control duties. Deployment of 800 National Guard personnel began in March.

TECHNOLOGY AND INFORMATION SHARING INITIATIVES

- In 2000, INS began development of an Enterprise Architecture project following Federal CIO Council guidance on federal enterprise architecture. This strategic effort will standardize, prioritize and integrate information technology support for INS enforcement and service functions and data requirements. This process is being expedited as a result of September 11.
- INS is moving quickly to implement the National Crime Information Center Interstate Identification Index (NCIC-III) at Ports of Entry. This system will allow Immigration Inspectors to identify applicants for admission with criminal histories and take appropriate action to apprehend them or deny them admission.
- INS is linking all of its law enforcement case management databases under the ENFORCE umbrella. Currently, ENFORCE is linked with the IDENT fingerprint system so that a biometric marker will be associated with each individual arrested and enrolled by INS law enforcement personnel. Deployment of IDENT/ENFORCE to all applicable locations has been approved. Mobile deployment of IDENT is being studied. Linking IDENT with the FBI's IAFIS system is in the pilot test phase.
- INS is working with the participants in the Interagency Border Inspection System (IBIS) to upgrade the Advance Passenger Information System (APIS) and allow that system to be the collection mechanism for all arrival and departure data received from airlines and cruise ships. This is part of the INS' effort to integrate entry-exit data collection in electronic form at airports and seaports. These efforts

include working closely with the USCS and other Federal inspections services, as well as private sector stakeholders and carriers, as required by law.

- In October, INS Commissioner James Ziglar and Assistant Secretary of State Mary Ryan agreed to deploy, within 90 days, the DOS Consolidated Consular Database, which includes nonimmigrant visa information and a photograph of the alien. The photograph will be available in secondary inspection for use as an additional tool and will assist inspectors in determining if a nonimmigrant visa holder is engaged in fraudulent conduct or is otherwise making a valid and legal application for admission. The deployment was completed in January 2002.
- INS has accomplished key steps for developing an entry-exit control system, which will match the arrival and departure of non-U.S. citizens. INS is committed to meeting a timetable to implement the entry-exit system at all 300 air, sea, and land ports of entry in the United States by the end of 2004.
- In July 2002, INS will begin deploying the internet-based Student Exchange Visitor Information System (SEVIS), the successor to CIPRIS. This system will maintain information on all foreign students with student or exchange visitor status in the United States and allow for instant access to that information.
- INS and U.S. Customs are reviewing the current Passenger Analysis Unit (PAU) capability to focus specifically on the Counter-terrorism mission. The PAU analyzes passenger names, current and historic flight data, and produces actionable, tactical intelligence for ports of entry.
- The INS and U.S. Customs Service are coordinating efforts to modify IBIS to accept electronic manifests beginning October 1, 2002. The INS and USCS are also working closely with the airlines and the Air Transport Association to meet the October 1, 2002 timeline.

INTERAGENCY AND INTERNATIONAL COOPERATIVE EFFORTS

- In September 2001, INS Commissioner Ziglar and Assistant Secretary of State Ryan jointly agreed to evaluate the effect of countries continued Visa Waiver Program designation on the law enforcement and national security interests of the US. Based on the evaluations, a determination will be made on whether program designation will be continued or terminated. In November 2001, the INS began by reviewing the program designations of Argentina, Belgium, Italy, Portugal, Slovenia, and Uruguay. The reviews are based on vulnerabilities on document security and overstay rates noted during the past several years. In February, the Attorney General terminated Argentina's participation in the Visa Waiver Program as a result of the immigration enforcement consequences of Argentina's recent economic collapse.

- Working with the State Department and other agencies, the INS has established and implemented procedure to fingerprint refugee applicants and undertake more extensive background checks of all refugee applicants.

- In September, the INS Commissioner met with the Secretary of the Interior to discuss joint efforts regarding border security on Native American lands contiguous to the international boundary. In addition, INS is pursuing Border Patrol recruitment efforts among Native Americans to increase its effectiveness in these areas. In January, INS hosted the first U.S. Border Patrol-Native American Border Security Conference. This event brought together leaders and law enforcement officials from Native American tribes to meet with representatives of the Border Patrol, the Bureau of Indian Affairs, and other agencies to explore ways to strengthen security along the Southwest and Northern borders.

- In October, representatives of INS and Citizens Immigration Canada (CIC) met to define joint responses to September 11. Representatives of the DOS, USCS, and the Royal Canadian Mounted Police also participated. Agreement was achieved on a broad range of action items aimed at improving security on the United States/Canada border and improving regional security generally in those areas within the responsibility and competence of the two immigration agencies. INS-CIC cooperation, coordination, and joint planning are long standing, but the events of September 11 have served to intensify this process and broaden the possibilities for harmonization of operations and policy.

- In October, representatives of INS and the DOS met with representatives of the European Commission Ministry of Justice and Home Affairs, and on October 26 with the EU Strategic Committee on Immigration, Frontiers, and Asylum (SCIFA) to initiate discussions on areas of cooperation between the U.S. and the EU to improve methods to identify terrorists, criminals, and unlawful migrants and prevent their entry into or passage through our respective territories. Cooperation on issues relating to removals was also discussed. These EU bodies will review the U.S. recommendations and schedule further discussions to agree on specific action items.

- In December, Homeland Security Director Ridge and Canadian Minister of Foreign Affairs Manley signed a Smart Border Declaration, which includes 30 initiatives aimed at enhancing security along our shared border. The INS played a major role in shaping this agreement.

- In January, both INS and U.S. Customs, working together with other U.S. agencies, participated in the United States/Canada Border Accord and Border Vision with their Canadian counterparts. The Border Accord and Border Vision groups address numerous issues related to the effectiveness and efficiency of not

only the U.S./Canada border, but other immigration policies such as asylum and visa harmonization.

- In January, Project Northstar hosted a meeting in Niagara, Ontario to discuss the formulation of Integrated Border Enforcement Teams along the U.S./Canada Border. Among the 200 participants were members of the CIC, Royal Canadian Mounted Police, Canadian Customs Revenue Agency, as well as the USCS.
- On March 4, Governor Ridge, Commissioner Ziglar and other senior government officials traveled to Mexico City, Mexico, to discuss measures for strengthening our joint security and to build on recent INS cooperative efforts with the Mexican government.
- On April 8, INS announced proposed regulatory changes that would:
 - (1) eliminate the minimum 6-month admission period for individuals entering on tourist visas, and instead base the admission period on the amount of time needed to accomplish the purpose of the trip;
 - (2) reduce the maximum initial admission period for persons entering under visitor visas (known as B visas) to six months;
 - (3) limit the conditions for which an extension of stay in B nonimmigrant visitor status can be granted and reduce the maximum length of that extension and
 - (4) create a legal requirement for persons with a final order of removal to surrender for removal within 30 days of the final order.

In addition, INS issued a rule change, which took effect immediately, that prohibits B nonimmigrant visitor visa holders from attending school prior to obtaining approval of a change to student status.

We shall send any refund received from the service suppliers or wholesalers to you within 2 working days after the refund received by us has cleared the bank.

At the request of Representatives Dingell and Waxman, the General Accounting Office has been investigating the makeup and deliberations of the Administration's energy task force. Those efforts were set aside after the tragedies of September 11. We write you today to urge you to continue this investigation.

The tragedies of September 11 forced Congress and the Administration to focus their attention on combating terrorism. However, now as the war continues to go well and we turn to domestic issues, Americans have the right to know how the Administration's energy policy was developed. Soon, Congress will begin to consider legislation that will establish a national energy policy, but we still have very little information about the makeup and conduct of the Vice President's task force, even though it was established and run by the executive branch of government and was, by all accounts, the basis for the President's energy plan.

Who helped shape the Administration's energy policy? How did participants get invited and what interests did they represent? What did they recommend? What changes did they request? The American public deserves answers to these questions.

Our concern is that we would be setting a dangerous precedent, and would be shirking Congress's oversight responsibilities if these questions are not asked, or if the Administration is allowed to avoid answering them. As the investigative arm of Congress, we believe it is the responsibility of the GAO to look into this situation.

KEY SENATORS ASK GAO TO PURSUE ADMINISTRATION'S ENERGY TASK FORCE INFORMATION

(WASHINGTON, D.C.) --- Four key U. S. Senators, in a letter sent today to the General Accounting Office (GAO), asked that it continue to seek information about the makeup and deliberations of the Bush Administration's energy task force.

The request was originally made by Reps. John Dingell (D-MI) and Henry Waxman (D-CA) prior to U.S. House consideration of the Energy Bill. Renewing the request today, are Senators Ernest "Fritz" Hollings (D-SC), Byron Dorgan (D-ND), Joseph Lieberman (D-CT) and Carl Levin (D-MI).

The House has completed its work on the energy bill, but the Senate has yet to take it up. The four Senators, who chair the Commerce Committee and the Government Affairs Committee, and their relevant subcommittees, are requesting that the GAO continue to seek the information which they say the Senate needs, before the Senate begins its consideration of the energy bill.

Prior to September 11th terrorist attacks, the GAO announced that the Administration was withholding the information. The GAO, which is Congress's investigative arm, responded that it had a right to the information and that it was prepared to go to court to enforce a requirement that the Administration turn over information.

The four Senators said they feel the Senate deserves the information prior to its consideration of the energy bill. That view has been supported by Republican Senator Fred Thompson (R-TN) who has publicly said the Administration should release the information as well.

The text of the letter, to David Walker, Comptroller General of the GAO, follows:

Dear Mr. Walker:

At the request of Representatives Dingle and Waxman, the General Accounting Office has been investigating the make up and deliberations of the Administration's energy task force. Those efforts were set aside after the tragedies of September 11. We write you today to urge you to continue this investigation.

The tragedies of September 11 forced Congress and the Administration to focus their attention on combating terrorism. However, now as the war continues to go well and we turn to domestic issues, Americans have the right to know how the Administration's energy policy was developed. Soon, Congress will begin to consider legislation that will establish a national energy policy, but we still have very little information about the makeup and conduct of the Vice President's task force, even though it was established and run by the executive branch of government and was, by all accounts, the basis for the President's energy plan.

Who helped shape the Administration's energy policy? How did participants get invited and what interests did they represent? What did they recommend? What changes did they request? The American public deserves answers to these questions.

Our concern is that we would be setting a dangerous precedent, and would be shirking Congress' oversight responsibilities if these questions are not asked, or if the Administration is allowed to avoid answering them. As the investigative arm of Congress, we believe it is the responsibility of the GAO to look into this situation."

WASHINGTON, D.C. -- Calling her "clearly the most qualified candidate," Rep. Jim Ramstad is urging President Bush to nominate his sister for a lifetime job as a federal judge in Minnesota.

In a letter to the president, Ramstad, R-Minn., recommended three Minnesotans for the job, but said that his sister -- Minnesota Corrections Commissioner Sheryl Ramstad Hvass -- is his first choice.

"Most importantly, as her brother, I know Sheryl Ramstad Hvass to be a person of absolute integrity whose reputation and character are above reproach," Ramstad wrote in the private letter, a copy of which was obtained by the Star Tribune.

Ramstad had not divulged that he ranked the candidates when he gave their names to the White House, nor did he release the letter recommending them.

Disclosure of the letter puts Ramstad in the awkward position of having to defend using his political influence to help land a coveted job for a family member.

It also puts him at odds with Sen. Mark Dayton, D-Minn., who said Ramstad's choice of his sister "raises very serious questions about his objectivity."

"I raise the question: Is she the most qualified person in Minnesota for this selection?" Dayton said. "I think that he needs to be able to explain to Minnesota why this is in the public interest."

University of Minnesota political scientist Lawrence Jacobs said that because Ramstad failed to publicly reveal that he had recommended a specific candidate, his candor could become an issue. "Jim Ramstad has just put himself in the frying pan," he said.

Ramstad said Wednesday that the White House asked him "not to publicly comment on the recommendations or the process" and that he had been "as forthright as I could" in public statements. White House policy is to not discuss nominations until they are made public. Likewise, Ramstad Hvass has said she cannot comment.

Ramstad expressed concern that if the issue becomes "a hot political potato," his sister could be penalized.

"I just do not believe she should be penalized nor rewarded because she's related to me," he said.

U.S. senators normally have the privilege of recommending candidates for political patronage jobs in their state, providing that the president belongs to their party. But both Minnesota senators are Democrats. As Minnesota's highest-ranking Republican office holder in Washington, Ramstad has claimed that perquisite.

Dayton questioned that.

"It doesn't seem to me like a good setup procedurally to have any one congressman who's representing one-eighth of the state be solely responsible for recommending these appointments," he said.

Ramstad sent his list of choices to the president in a letter dated Nov. 12, two days after he and two others interviewed five finalists for the judgeship, which opens in February.

Ramstad Hvass, a former federal prosecutor, state judge and practicing attorney, has long been in the mix of Republicans considered for such jobs.

In his two-page letter to Bush, Ramstad said his second choice is former assistant U.S. attorney Jon Hopeman and his third is Minnesota Supreme Court Justice Joan Ericksen Lancaster. He devoted eight paragraphs praising his sister and included her three-page resume. The other two finalists were mentioned by name and title only.

After reviewing the letter, Dayton said that Ramstad was making "a nominal submission" of three candidates while making an "emphatic" recommendation for his sister.

In a phone interview, Ramstad said that he never expected his letter to be made public, calling it "a personal correspondence with the president."

Asked whether he thought he could objectively evaluate his sister, Ramstad said, "Yes, and I have been objective."

To avoid the appearance of a conflict of interest, Ramstad said, he appointed a merit-selection panel, which evaluated 15 candidates. The panel included former Minnesota Supreme Court Chief Justice Douglas Amdahl, attorney M. Jacqueline Regis of the St. Paul Companies and former assistant U.S. Attorney Doug Kelley.

Kelley said Ramstad's office sent him a stack of resumes, but told him that the committee was free to solicit other candidates. The three panelists said nobody pressured them to choose one candidate over another.

"I'm sure we all knew that she was the sister of Congressman Ramstad, but I can't recall there was any more discussion about her than there was about anybody else," Amdahl said.

Kelley said the group decided to choose the five best candidates and "political considerations would be made by Jim himself."

The other two selections were former Hennepin County District Judge Richard Solum and Minneapolis attorney Gary Haugen. Solum said he withdrew.

Kelley said the committee did not rank the five finalists.

President Bush will choose the final nominee, who then must be approved by the Senate.

Dayton said he is reserving judgment on any nomination but is "not aware of anything to her detriment." He said his main complaint focuses on the selection process.

Dayton said he expressed displeasure to Ramstad last month after learning that Ramstad was proceeding with the judicial recommendations on his own.

Sen. Paul Wellstone, D-Minn., said in a statement that Ramstad had assembled a distinguished merit-selection panel and that all three finalists "appear to be well qualified."

Prof. Jacobs said that Ramstad is "pretty much perceived as squeaky clean" but that "Americans generally don't like to see" politicians promote their family members for prestigious jobs.

The judgeship is one of seven in Minnesota that, effective Jan. 1, will draw a salary of \$149,017.

John Hibbing, a University of Nebraska political science professor who is an expert on public perception of Congress, said Ramstad's decision to winnow the five finalists himself undercuts his merit-selection process.

"He clearly was machinating to get an outcome that he desired," Hibbing said.

Ramstad, who was first elected to Congress in 1990, is widely popular in his suburban Minneapolis district, winning elections by wide margins.

Washington lawyer Judah Best, a former chairman of the American Bar Association's judicial selection committee, said the issue regarding Ramstad Hvass is "not how she got there, but rather, what is the professional competence of this person? What's her integrity? What's her judicial temperament?"



Accept the Bad with the Good

The stock market confronts prospects both good and bad. But if you try to jump out of stocks when you think the bad predominates and jump in again later at lower prices, more often than not, you will fail.

Here are the principal investor concerns today:

1) The Internet is burdened with so much overcapacity that technology won't recover for years.

This I wouldn't worry about. Only about 10 percent of the fiberoptic lines installed in the last few years are in use. But the lines themselves were only a minor part of the expenses. Acquiring the rights of way and digging the trenches were the main costs. It was better to install an excess of lines from the beginning so that the trenches need not be reopened soon.

2) We could suffer another terrorist attack.

It could happen. But the terrorist bases of operation are being terminated, their training camps closed down, and their funding shut off. The technologies of chemical and biological weapons are too complex to harm many people in the west. Terrorists would like to get their hands on uranium, but there's no evidence they've succeeded. Saddam won't develop the bomb for another two or three years; by then, he'll be history. The war is working. Within five years, the world will be safer. Even the Muslim nations will have begun their progression into the 21st century.

3) The economy will remain weak.

I have qualms about this too. Raising tariffs on steel and on Canadian lumber were serious mistakes. Impediments to trade lead to economic disaster. Does President Bush think that other nations won't reciprocate?

Government in the U.S. is growing faster than the economy, a trend that usually leads to trouble. Yes, there's a war on, but couldn't expenditures be cut somewhere else? Of course not; the pols wouldn't think of it.

Mr. Bush caved in too quickly on educational vouchers. Without competition from private schools, many public schools will remain failures. Poor schools hurt the blacks most. Don't the blacks count?

The President failed to fight for Mr. Pickering and other nominations to the U.S. Appeals Courts. The U.S. Supreme Court accepts only 2 percent of the cases presented to it. For most cases, the Appeals Courts have the final say. The Senate has held up most of Mr. Bush's nominations to these courts.

The President failed to fight for cutting the tax rates immediately. Lower tax rates make a stronger economy.

The campaign reform bill Mr. Bush is signing suppresses free speech. Didn't the oath of office to defend the Constitution mean anything to him?

The President's quick surrender on these matters hurts America and hurts the long-term prospects for the stock market.

Except in war, President Bush is acting like a wimp, just as his father did. He must exert himself against more than just the terrorists. The American people respect a fighter. Never mind waiting for 2002 and 2004 elections; Mr. Bush must fight all the way along the line.

But there's good news amidst the bad. Freedom, while diminishing in America, is gradually increasing in the rest of the world. The Federal Reserve's monetary policy is helpful. Most importantly, a surge of new technologies will raise the output per man-hour of labor (productivity).

High productivity sustained us during the recession. As time goes on, the output of goods and services will increase faster than the supply of money. Inflation will therefore drop and interest rates decline – both positive for the stock market.

Stock prices always confront the bad and the good. No one can consistently balance one against the other with such precision as to jump out of the market at the right time, pay the taxes, wait out a sharp market decline and pop in again at the bottom. You might luck out once. But your success will embolden you to try again. This time you'll fail. Fail once at market timing, and you're left way behind.

Better to take the bad with the good. Better to slog ahead with stock investments, through thick and thin. As long as you're well diversified with domestic stocks, foreign stocks, real estate investment trusts, and bonds, you can do no better.
