



Dear Karl:

The "Houses of Worship Political Speech Protection Act," (HR-2357) is a measure designed to advance free speech and to curb the unbridled discretion of the IRS by amending section 501(c)(3) of the Internal Revenue Code ("IRC"). Under current tax law churches and houses of worship are banned from all activity that the IRS may regard as "participating or intervening in" any political campaign. Churches have lost their tax exemption for a single breach of this ban.

HR-2357 redresses the problem by adopting the "no substantial part of the activities" standard used in the law for regulating the lobbying and legislative activity limits in which churches and exempt organizations may engage.

Election day sermons have been a hallmark of American democracy since the Founding. Until 1954, all houses of worship were afforded the full and clear opportunity to act and speak as their conscience and leadership may direct, even in the political area. Today houses of worship do not enjoy that freedom because of the "Johnson Amendment," which was inserted into the tax law in 1954 without debate or hearing. Senator Johnson was angry that two Texas charitable groups had criticized him during the primary for not being as anti-communist as Texas deserved.

In hearings held last Tuesday, May 14, 2002, Steven T. Miller, Director, Exempt Organizations Division, IRS, acknowledged that endorsement by a pastor, priest or rabbi from the pulpit would be a violation of the law.¹ He also confirmed that a single violation warranted

loss of exemption. IRS expert Bruce Hopkins also testified that he believed modifying the political intervention ban as proposed is constitutionally permissible. He noted that the tax code is filled with instances where Congress has recognized the constitutional uniqueness of churches, and treated them differently than other exempt organizations, and none of those distinctions had ever been struck. For example, all exempt organizations, except churches, must file for recognition of tax-exemption, and all must file annual informational tax returns, except churches, and only churches are given the unique protections of the *Church Audit Protection & Procedures Act* (IRC 7611).

Those opposing the bill have insisted that replacing the absolute ban on political intervention with the "no substantial part" test currently used in the lobbying context would create a loophole in the nation's campaign finance system. Such an assertion is unfounded, however. Under the new *Bipartisan Campaign Finance Reform Act of 2002*, which amends the *Federal Election Campaign Act*, all corporations, including tax-exempt nonprofit corporations, are barred from making "hard money" contributions, or any direct or indirect disbursements for "electioneering communications." *BCFRA* §§ 101(a); 102(b); *FECA* §§ 431(22); 441b(b)(2). These restrictions apply right now, and will continue to apply regardless of any changes to the tax code which may be made by the passage of the "*Houses of Worship Political Speech Protection Act*."

Since the beginning of the tax code churches and houses of worship have been exempt from income taxes because they provide services and promote the general welfare, saving those costs to the government. That fundamental relationship will not be changed by abandoning the absolute political intervention ban and replacing it with the "no substantial part" test. Passage of HR 2357 will not require houses of worship to affirmatively do anything, or fundamentally change their functions.

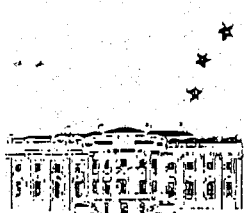



Outline of Newt Gingrich Testimony for May 22, 2002

We Must Expand Our Investment in Science

1. The Hart-Rudman Commission on National Security to 2025 warned that our failure to invest in science and to reform math and science education was the second biggest threat to our national security. It warned that only the threat of a weapon of mass destruction in an American city was a greater danger. In fact, the Commission unanimously concluded that the danger from under investing in math and science and failing to reform math and science education was greater than the danger from any conceivable conventional war.
2. The explosion of knowledge in nanoscale science and technology and in the quantum behaviors associated with that scale (from smaller than one atom to about four hundred atoms) represents a profound transformation in our understanding of the natural world. Every member of Congress should take time to learn the basics of nanoscale activities and the potential of quantum behaviors.
3. These changes will be so profound they will effect biology, chemistry, physics and the basic building blocks of every aspect of life and civilization. Our approach to health, the environment, productivity and national security will all be profoundly shaped by this emerging revolution in knowledge.
4. The knowledge breakthroughs of the next 20 years will equal the entire 20th century. In other words the rate of change is accelerating and in the next two decades will be about 5 times as fast as the 20th century. The rate will continue to accelerate and we will match the 20th century again between 2020 and 2035.
5. Countries which fail to invest in basic science and math and which fail to insist on adequate math and science education will fall behind economically and in national security capabilities.

6. The United States lead today is a function of past investments. Our ability to lead in 2020 is a function of current decisions. There is no reason today to believe we will automatically maintain that lead.

7. We graduate too many lawyers and too few scientists and engineers. We produce too few high school students capable of doing college math and science and too few college graduates capable of doing graduate work in science and math.

8. If the present trends continue we will be surpassed by China and India in the next generation and we might be passed by Japan and Europe.

9. To meet this challenge the National Science Foundation should be increased to a \$15 billion a year budget. It is clear that the National Science Foundation could invest \$11 billion a year within current constraints (see prior testimony by the Director, Dr. Colwell). It is clear that instrumentation, education, and research projects could absorb a \$15 billion level productively.

10. The National Nanotechnology Initiative should immediately be expanded to \$1,100,000 in the coming year and should grow at 15 to 20% a year after that.

11. The National Institutes of Health should be instructed to invest at least three per cent of their research efforts into nanoscale activities.

12. The math and science educational efforts at k-12 and in undergraduate collegiate education have to be thoroughly overhauled with a focus on results rather than intentions. Reforming education in this area is a matter of national security priority and if we fail at it we should expect to decline as a power and to fall behind other countries in a generation.

13. The Congress should contract with the National Academy of Sciences for paid analysis and advice instead of attempting to recreate the Office of Technology Assessment. Every member of Congress should spend some time each year becoming scientifically informed.

Tim, I am forwarding to you a memo and brief synopsis of the new tax on church employees. Please share this with key folks there.

I appreciate the Administration's efforts on behalf of the religious community and faith-based ministries and community organizations. The President's remarks on the CARE Act (04-11-02) were most helpful. Thanks for including me.

"The other thing the federal government must not do is worry about the role of faith-based programs in providing help to people in need. Let me put it a little more bluntly: the federal government should not discriminate against faith."

Unfortunately, I believe the action taken by the IRS runs counter to the President's intent on faith based ministries as well as school choice/education tax credits. Just as the President is successfully reaching out to the religious community, and many which ordinarily would not support his policies, the IRS undertakes an action, which if heavily publicized could embarrass the Administration as well as hinder its political outreach to new constituencies (Catholic, Jewish, Muslim, and moderate Protestantism). It will also redirect lobbying efforts away from the CARE Act towards correcting this problem. Further, if the ruling is protected, it could diminish the enthusiasm and turnout of religious conservatives. In essence, support of the IRS action will yield very little revenue for a much higher political expense.

Remember, the vast majority of church employees are not highly compensated; as additional financial burdens are imposed recruitment for service is diminished. I do not know of any one who decided to work for a ministry to get rich-all are Spirit driven. Most ministries try to adjust for financial hardship by offering employee benefits. It's inconsistent that a church employee will be taxed for receiving free or reduced tuition, while a church employee can get a tuition scholarship from a scholarship tuition organization

tax-free.

The purpose of the law should not be to lead us toward temptation, that is, toward creative measures to evade the tax, or other laborious and bureaucratic means to comply. I for one do not believe that the IRS instituted the policy to help expand scholarship tuition organizations. Basically, certain church employees will be triple taxed; pay state and local for public schools, pay federal income tax which includes support for public schools, and then an additional tax on their families tuition benefit. This policy, regardless of intent will leave children of church employees behind.

I just want to remove impediments to religious service and the growth of private, religious schools. I encourage the Administration to repeal the IRS Private Letter Ruling 200149030 as soon as possible. Second, the Administration's support for Congress to legislate this benefit as exempt from taxes would be welcomed and viewed as a mark of leadership.

Remarks on the CARE Act (04-11-02)

President George Bush

Although President Bush has stated that government should not discriminate against faith, religious organizations are now being subjected to an additional burden by another arm of the Administration-the IRS. On December 7, 2001, the IRS quietly released a surprise "tax" attack on the nation's most faithful and hardworking servants, church employees. Ironically, this occurs while the President is encouraging faith-based and community institutions, family groups as well as Americans of faith to support and urge the adoption of the CARE Act in the US Senate before Memorial Day.

A common practice in Christian schools is to allow a free or reduced tuition rate for church and school employees. A recent IRS private letter ruling, "200149030" (a private letter ruling is a temporary regulation until a final regulation is written) will now restrict that tax-free tuition benefit to school employees only. The IRS ruled that because church employees do not work for an "educational institution," they will have to pay taxes on the benefit. The ruling states:

The employees generally of such an "educational organization" would be eligible to receive excludable "qualified tuition reductions" from their employer; the exclusion is not limited solely to individuals providing teaching services, but would extend to the employees generally within such function, including secretarial, managerial, administrative, and support function employees. However, in these circumstances, an excludable Section 117(d) benefit could not be extended to church employees who were not employed within the context of the school function, or "educational organization," so defined.

Some background for your meeting on State and Local Law Enforcement Initiatives. Below are some concerns from local officials and Latino groups:

Local Officials:

- Some mayors have policies against city police participating in or enforcing immigration and naturalization efforts.
- The Big Seven and many local officials will likely describe this as a new mandate for local law enforcement, and they will lobby for more federal dollars to off set additional costs. Any assistance to INS should be compensated. This is a serious issue in some West and Southwest communities.
- There is a concern that such authority will undermine community relations efforts with minority/immigrant communities.

Latino Advocates:

- Local law enforcement officers need appropriate training before being allowed to enforce these laws.
- Law enforcement officers should only enforce INS civil laws when a suspect is involved in actual criminal activity.

Dear Chairman Lieberman:

When we first spoke about the request of the Committee, I told you that the White House would cooperate to make appropriate information available to the Committee. I confirmed our cooperative approach in my letter to you of April 19, stating that we "support the Committee's objective" and would "assist the Committee by taking reasonable steps to gather certain information for the Committee."

Since then, we have done so. As I wrote you on May 16, we already have taken numerous steps to gather information requested by the Committee. We are gathering and reviewing documents. We are gathering and reviewing e-mails. We are gathering and reviewing visitor entry records. We are interviewing individuals with relevant information. And we are preparing to respond soon to assist the Committee's inquiry in a time frame we had originally discussed with your staff.

We respectfully believe, therefore, that the Committee would be acting precipitously -- and in a manner inconsistent with the traditional inter-Branch accommodation process -- by issuing a subpoena at this juncture in the inquiry.

The Committee's approach also is in tension with the case law. The D.C. Circuit has held that Congress seldom needs a "precise reconstruction of past events" in order to legislate. *Senate Select Committee on Presidential Campaign Activities v. Nixon*, 498 F.2d 725, 732 (D.C. Cir. 1974) (en banc). And even when Congress has authority to inquire, it may not intrude unduly on presidential prerogatives or demand all information within the scope of a presidential privilege. Rather, a committee must establish that "the subpoenaed evidence is demonstrably critical to the responsible fulfillment of the Committee's functions." *Id.* at 731.

Most important for present purposes, the case law recognizes that, as here, there may be inter-Branch disputes about whether Congress has a sufficient predicate and, if so, whether it is unduly intruding on Executive Branch prerogatives. The case law recognizes, in particular, that the respective interests of the two Branches may conflict when Congress seeks to inquire into the activities of the Executive Branch -- especially when it seeks to inquire into activities of the Executive Office of the President and the Office of the Vice President. As the D.C. Circuit has stated:

The framers . . . expect[ed] that where conflicts in scope of authority arose between the coordinate branches, a spirit of *dynamic compromise* would promote resolution of the dispute in the manner most likely to result in efficient and effective functioning of our governmental system. . . . [E]ach branch should take cognizance of an implicit constitutional mandate to seek optimal accommodation through a realistic evaluation of the needs of the conflicting branches in the particular fact situation. . . . The Constitution

contemplates such accommodation. Negotiation between the two branches should thus be viewed as a dynamic process affirmatively furthering the constitutional scheme.

United States v. American Tel. & Tel. Co., 567 F.2d 121, 127, 130 (D.C. Cir. 1977) (emphasis added).

Consistent with this case law, we have taken extensive steps to accommodate the Committee's request, as detailed above and in my letter of May 16. We respectfully do not believe that the Committee has similarly engaged in the process of dynamic compromise and optimal accommodation. In our meetings with you and your staff, the Committee has not attempted reasonably to clarify, define, prioritize, or otherwise accommodate our attempts to seek reasonable clarifications of the Committee's request. The Committee's failure to reasonably define its request is a factor that has affected the timing of the Committee's receipt of information. We nonetheless have gathered substantial information and would be prepared soon to submit appropriate information to the Committee.

Your May 16 letter states that you would not seek a subpoena this week if I can assure you:


(1) [we] will promptly take steps to broaden the search along the lines discussed above and in the Committee's May 3 letter in order to obtain all information sought in the Committee's March 27 letter, and (2) [we] will provide the Committee all information sought in the Committee's March 27 letter by the end of May.

As to your first condition, we believe we can satisfy you by submitting the Enron surveys to all employees of the Executive Office of the President and the Office of the Vice President. We contacted your staff on May 17 to offer the accommodation of circulating the survey to all such employees if you would withdraw the threat to seek a subpoena. We have yet to hear your response.

As to your second request, we think your demand premature. It would be irresponsible, in my judgment, for my Office to commit in advance to provide information to Congress before we have reviewed it to assess whether disclosure would be inconsistent with the effective operation and long-term institutional prerogatives of the Presidency. Let me emphasize, however, that we have no intention of unnecessarily provoking a confrontation with the Committee. We simply believe it unusual and inappropriate for a congressional committee to threaten a subpoena simply because the President's counsel has not committed *in advance* to provide the Committee every shred of information -- no matter how sensitive to the Presidency, no matter how extraneous to the Committee's inquiry.

In sum, I respectfully suggest that you reconsider and withdraw the threat of a subpoena until, at a minimum, you can review the information we intend to provide soon to the Committee.

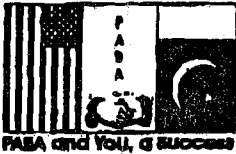


