**POLICY ANALYSIS AND RECOMMENDATIONS CONCERNING BOSNIA-HERZEGOVINA  
EXECUTIVE SUMMARY**

(of paper dated 9 September 1994)

**Analysis**

1. Bosnia and the Balkans are an area with a history of bitter ethnic and religious conflict which the U.S. would do well to avoid.
2. U.S. security increasingly depends on the European bloc because U.S. resources and leverage are no longer so predominant.
3. Nationalism in Eastern Europe is on the rise, and it is of the virulent, pre-World War II type. Our Western liberal philosophy must not be allowed to keep us from recognizing the serious ethnic and religious antagonisms which typify the Balkans and Eastern Europe.
4. The war in Bosnia resulted from the Bosnian Serbs' unwillingness, deliberately exacerbated by Serbian President Slobodan Milosevic, to live under a Muslim-led government when the republic declared its independence from Serb-dominated Yugoslavia. The Serbs see the Muslims as apostates from the Orthodox faith and as descendants of those who collaborated with the hated Turkish oppressors.
5. A large quantity of arms, including state-of-the-art weapons, has been getting through to the Muslims and Croats in spite of the embargo, especially since April, 1994.
6. Although the question of U.S. involvement in Bosnia is still hotly debated, all sides are united concerning the necessity of keeping the war from turning into a wider Balkan conflagration.
7. Russia's movement toward democracy has stalled, and the privatization of large industrial combines through the issuing of ownership vouchers, with most of the Communist-era managers still in charge, does not really constitute movement toward a "market economy". Much of the rest of the new private sector is dominated by the mafia.
8. Although Vladimir Zhirinovskiy's personal popularity has fallen somewhat, and he now has serious competition for the leadership of the "National-Patriotic" movement, his largely fascist ideas still have a significant following among the Russian people.
9. Russia is implementing a clear strategy to use the Commonwealth of Independent States (CIS) as a framework to re-integrate all the former territory of the Soviet Union, with the possible exception of the three Baltic republics, under Russian domination.
10. A "Weimar Scenario", according to which Russia's fledgling democracy would be replaced by a fascist-oriented "National-Patriotic" government, is fairly likely. The one significant factor which argues against it is the high Russian tolerance for suffering.

**Recommendations**

1. Containment of the war in Bosnia-Herzegovina/former Yugoslavia by:
  - (a) greatly augmenting the 500 man U.S. presence in Macedonia, considering withdrawing it from UNPROFOR and modifying its ROEs.
  - (b) doing everything possible to avoid encouraging the Kosovars to fight for their independence from Serbia, and also keep Albania from encouraging the Kosovars;
  - (c) putting pressure on the Croats not to seek a "final solution" to the "occupation" of one-third of Croatia by the Krajina Serbs;
  - (d) putting pressure on the Greeks to lift their embargo against Macedonia (FYROM), to tone down their threats regarding the trial of members of the Greek minority in Albania, and to stop their large-scale expulsions and repatriations of Albanian refugees.
  - (e) conditioning U.S. aid on Albania's defusing the tension with Greece by postponing or quickly concluding (with minimal sentences) the current trial of the members of the Greek minority.
  - (f) putting pressure on Turkey, Bulgaria, Romania and Hungary to avoid any actions or statements which could encourage the formation of competitive alliances, such as a Greek-Serb-Romanian against an Albanian-Macedonian-Bulgarian-Turkish axis.
