- That is why you at HUD are so important. The employees of this Department make homeownership possible for more American families. Employees like the Acting Assistant Secretary for Policy Development and Research, Larry Thompson. Larry will retire at the end of June after thirty years of service. Thank you for your service, Larry.
- Through the help of all of you, America has enjoyed an increase in home ownership. Yet today, while nearly three quarters of white Americans own their own homes, fewer than half of all African Americans and Hispanics are homeowners.
- We are dedicated to a great national goal that all of you will have a central part in achieving. We are determined to increase minority homeownership by at least five and a half million families by 2010. To help close the "homeownership gap" we must knock down three barriers that prevent many minorities from owning a piece of the American Dream.

- The greatest single barrier to first-time homeownership is a high down payment that low-income families cannot afford.
  - To help knock down that barrier, my Administration is proposing the American Dream Downpayment Fund. When a qualified low-income family is qualified to buy a home, but comes up short on the down payment, the American Dream Downpayment Fund will help provide the needed funds. It will help about 40,000 families per year become homeowners.
- A second barrier to family ownership is a lack of affordable housing. Too many neighborhoods – especially inner-city neighborhoods – lack good homes that families can afford.
  - To help knock down that barrier, we are proposing a Single Family Affordable Housing Tax Credit. Over the next five years, this initiative will provide developers with nearly 2.4 billion dollars in tax credits for building affordable single-family housing. It will make up to 200,000 new homes available to low-income purchasers when fully implemented.
- A third major barrier to minority homeownership is the complexity and difficulty of the home buying process.
  - To help knock that barrier down, Secretary Martinez and this Department are working to make closings less complicated. We are also stepping up our efforts to better educate first-time home buyers, including immigrants who have little experience with our financial institutions. Education is the best protection for families against unscrupulous lenders. Financial education and housing counseling can help protect home buyers, greatly improve the loan terms they are offered, and help families survive tough times with their homes intact.
- We also want to fully implement the Section 8 Homeownership Program. This program will provide vouchers that first-time home buyers can use to help pay their mortgages or apply toward a down payment.

- But government cannot do the job alone. That is why I have challenged the private sector to join us in a national effort to dismantle the barriers to homeownership.
- The private sector can expand the capital available to minority families, overcome the barriers they face in getting credit, build more houses in their neighborhoods, and help guide them through the home buying process. The real estate industry is already stepping up to the plate – and America is grateful.
- To encourage everyone to stay focused and committed, yesterday I announced that we will host a White House Conference this fall to promote and increase homeownership. Secretary Martinez will Chair the Conference, which will develop additional approaches aimed at closing the “homeownership gap.”
- Making the American Dream come true means helping more American families own their own homes. That is what all of you at our Nation's homeownership agency do every day, and I thank you for helping dreams come true in America.

- The greatest single barrier to first-time homeownership is a high down payment that low-income families cannot afford.
  - To help knock down that barrier, my Administration is proposing the American Dream Downpayment Fund. When a qualified low-income family is qualified to buy a home, but comes up short on the down payment, the American Dream Downpayment Fund will help provide the needed funds. It will help about 40,000 families per year become homeowners.
- A second barrier to family ownership is a lack of affordable housing. Too many neighborhoods – especially inner-city neighborhoods – lack good homes that families can afford.
  - To help knock down that barrier, we are proposing a Single Family Affordable Housing Tax Credit. Over the next five years, this initiative will provide developers with nearly 2.4 billion dollars in tax credits for building affordable single-family housing. It will make up to 200,000 new homes available to low-income purchasers when fully implemented.
- A third major barrier to minority homeownership is the complexity and difficulty of the home buying process.
  - To help knock that barrier down, Secretary Martinez and this Department are working to make closings less complicated. We are also stepping up our efforts to better educate first-time home buyers, including immigrants who have little experience with our financial institutions. Education is the best protection for families against unscrupulous lenders. Financial education and housing counseling can help protect home buyers, greatly improve the loan terms they are offered, and help families survive tough times with their homes intact.
- We also want to fully implement the Section 8 Homeownership Program. This program will provide vouchers that first-time home buyers can use to help pay their mortgages or apply toward a down payment.

- But government cannot do the job alone. That is why I have challenged the private sector to join us in a national effort to dismantle the barriers to homeownership.
- The private sector can expand the capital available to minority families, overcome the barriers they face in getting credit, build more houses in their neighborhoods, and help guide them through the home buying process. The real estate industry is already stepping up to the plate – and America is grateful.
- To encourage everyone to stay focused and committed, yesterday I announced that we will host a White House Conference this fall to promote and increase homeownership. Secretary Martinez will Chair the Conference, which will develop additional approaches aimed at closing the “homeownership gap.”
- Making the American Dream come true means helping more American families own their own homes. That is what all of you at our Nation’s homeownership agency do every day, and I thank you for helping dreams come true in America.

I. PURPOSE

To meet with the national leadership of the Disabled American Veterans for a photo-op.

II. BACKGROUND

This is a courtesy meeting with the Disabled American Veterans' National Commander, its National Adjutant, and its Executive Director. The participants understand this meeting is not for a policy discussion on DAV issues.

The following background is provided for your information. The DAV believes that service-related disability compensation to retired service members should not be offset against veterans' retirement pay. But the VA estimates that allowing concurrent receipt of military retired pay and VA compensation would cause, over the next five years, the filing of 700,000 new claims from retirees who have not previously filed for compensation benefits and would reopen 118,000 claims from military retirees currently on VA compensation rolls. Your Administration estimates that 50 percent of these claims would be received in the first year following enactment of the legislation allowing concurrent receipts. First-year VA costs would approach \$766 million in benefits, and first-year DoD costs are estimated at \$3.1 billion; combined costs over ten years would be \$57.9 billion. Members of Congress have proposed varying bills addressing this issue.

Your Administration's position on concurrent receipts is clear. We have consistently opposed changes in the law that would allow military retirees to receive VA disability compensation, without waiving an equivalent amount of military retirement pay. In our recent SAPs, we stated that allowing concurrent receipt is contrary to the long-standing principle that no one should receive concurrent retirement benefits and disability benefits based upon the same service.

The DAV also believes government funding for veterans' health care should be mandatory, not discretionary. Your Administration is opposed to the mandatory funding of veterans' health care, and, as you know, generally opposes mandatory funding requirements.

### **GEORGE H. STEESE, JR.**

A disabled Vietnam veteran, George H. Steese, Jr. is national commander of the DAV. A native of Los Angeles, Mr. Steese enlisted in the U.S. Air Force in 1968. In 1971, while serving as a supply specialist in aircraft parts with the 475th Combat Support Group at Misawa Air Base, Japan, he suffered an injury to his back. He was honorably discharged at the rank of staff sergeant in 1979. Since 1988, he has been confined to a wheelchair as a result of his service-connected disability.

Mr. Steese joined the DAV Chapter 1 in Fresno, California, in 1983. He is still a member and has served as chapter commander and treasurer. He is also a DAV Department of California past commander and was selected Department of California Veteran of the Year for 1998. Mr. Steese earned his bachelor's degree in business administration with an accounting emphasis from California State University at Fresno in 1984.

### **ARTHUR H. WILSON**

An Air Force veteran disabled in Vietnam, Arthur H. Wilson was appointed national adjutant of the DAV in June 1994. As the DAV's senior staff official, Mr. Wilson serves as the organization's CEO and leads the DAV's staff of 650.

Mr. Wilson, the first Vietnam veteran to enter the DAV's National Service Program, previously served as executive director of DAV's Washington headquarters, guiding the organization's national service, legislative, employment, and voluntary service programs. Mr. Wilson began his DAV career in 1966 when he joined the DAV's staff as a national service officer (NSO) trainee in Atlanta.

A graduate of Lynn Classical High School in Lynn, Massachusetts, Mr. Wilson attended Burdette College in Lynn until enlisting in the Air Force in September 1962. While working as a runway construction specialist, Mr. Wilson saw combat in Vietnam and served in the Philippines, Thailand, and Taiwan. Shortly after his discharge, he underwent major surgery at a VA hospital.

### **DAVID W. GORMAN**

Mr. Gorman was appointed executive director of the DAV Washington headquarters in 1995. His responsibilities include oversight of the DAV national service, legislative, and voluntary service programs. He is the organization's main spokesperson before Congress, the White House, and the Department of Veterans Affairs. Mr. Gorman is an expert regarding the VA's complex array of services and programs. He has been asked to sit on numerous VA and Congressionally chartered advisory committees.

After attending Cape Cod Community College, Mr. Gorman entered the Army in 1969, serving with the 173rd Airborne Brigade, the famed "Sky Soldiers" of the Vietnam War. During a campaign to secure an area in central Vietnam where United States forces had suffered extremely high casualties, he stepped on a land mine and suffered wounds requiring amputation of both legs. Discharged from the Army in 1970, Mr. Gorman immediately joined the DAV and is a life member of the DAV's National Amputation Chapter and Chapter 12 in Rockville, Maryland.

## PAUL HARVEY BIO

Paul Harvey has said that he was raised in radio newsrooms. He has broadcast the news to millions, built an active professional life, and established himself as one of the foremost newsmen in the business.

Born and raised in Tulsa, Oklahoma, Mr. Harvey began his radio career in 1933 at KVOO-AM, Tulsa, while he was still in high school. Later, while attending the University of Tulsa, he continued working at KVOO as an announcer, then as a program director.

After graduation, Mr. Harvey spent three years as a station manager for a local station in Salina, Kansas. From there, he took a newscasting job at KOMA-AM in Oklahoma City, then moved on to KXOK-AM, St. Louis, where he was Director of Special Events as well as a roving reporter.

Mr. Harvey moved to Hawaii in 1940 to cover the U.S. Navy as it began to concentrate its fleet in the Pacific. He was returning to the United States from that assignment when the Japanese bombed Pearl Harbor. Mr. Harvey then enlisted into the Army Air Corps, in which he served until 1944.

After leaving the Corps, Mr. Harvey moved to Chicago, where in June 1944 he began broadcasting from the ABC affiliate WENR-AM. He quickly became the most listened-to newscaster in Chicago.

Harvey began reaching audiences well beyond The Windy City in 1951, when he began his coast-to-coast "News and Comment" on the ABC Radio Networks. On May 10, 1976, Mr. Harvey began another series of programs on the ABC Radio Networks entitled "The Rest of the Story," which delve into the forgotten or little known facts behind stories of famous people and events. His "News and Comment" and "The Rest of the Story" are to this day very successful shows.

Paul Harvey's reach continues to broaden in the 21<sup>st</sup> Century, as "News and Comment" is streamed on the world-wide-web twice a day. He is married to the former Lynne Cooper of St. Louis. They have one son, Paul Jr.
