- 12:45 p.m.      Ushers office will set 135 chairs, press risers, small podium platform and flags.
- 1:00 p.m.      WHCA will set audio and podium (Blue Goose).
- 1:15 p.m.      Lights will pre-set.
- 1:30 p.m.      Media will pre-set.
- 2:00 p.m.      Guests will arrive East Visitors Entrance.
- 2:15 p.m.      Final access for the media.
- 2:20 p.m.      Guests take their seats.  
11 judicial nominees and families are positioned in the State Dining Room. They move through the Red Room to the Blue Room for a photo with POTUS. They exit the Blue Room and take their seats in the East Room.
- 2:28 p.m.      Nominees will be seated in the front row of the audience.
- 2:30 p.m.      WHCA announces POTUS from the Blue Room.  
POTUS enters from the Blue Room through the Cross Hall.
- 2:31 p.m.      POTUS makes remarks.
- 2:40 p.m.      POTUS concludes remarks and invites everyone to the State Dining Room for a reception.
- 2:41 p.m.      POTUS shakes each nominee's hand and then walks through the Cross Hall to State Dining Room.
