Biographical History:

Daniel Scott Sullivan was born in 1964 in Ohio. He attended Culver Military Academy in Indiana and graduated magna cum laude from Harvard University, where he majored in economics. He then obtained both a law degree and a Master's in Foreign Service from Georgetown in 1993. Following his graduation, he enlisted in the Marines and served as an infantry and reconnaissance officer. Sullivan returned to the civilian life in 1997 when he and his wife, Julie Fate Sullivan, moved to Alaska. He practiced business and corporate law at the international firm of Perkins Coie, LLP.

In 2002, Sullivan became involved in the George W. Bush administration. He first served as a White House Fellow for both the National Security Council (NSC) and the National Economic Council. He then became a director in the International Economic Affairs directorate of the NSC.

His areas of focus included trade agreements between the United States and other countries, intellectual property rights, international economic group affairs (such as the G8, World Trade Organization, and APEC (Asia Pacific Economic Cooperation)), as well as steel-related issues. He temporarily served as acting senior director for the office from June - August 2004.

In December 2004, Sullivan was recalled to active duty and was forced to leave his position at the White House. During this time, he worked as a Strategic Advisor and Special Assistant to the Commander of U.S. Central Command (CENTCOM). His tour ended in April 2006 and he returned to the Washington, DC area. In June 2006, he became Assistant Secretary of State for Economic, Energy, and Business Affairs under Condoleezza Rice. In this position, he focused on economics, energy, finance, sanctions, and terrorist finance. At the end of the Bush administration, Sullivan returned to Alaska. He was appointed Attorney General by Governor Sarah Palin in June 2009. In 2010, he became the Natural Resources Commissioner for the state. In November 2014, he was elected to the United States Senate representing Alaska.

Scope and Content

The materials in FOIA 2014-0302-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0302-F contains the staff member office files of Daniel Scott Sullivan in his capacities as a White House fellow (2002-2003) for the National Security Council (NSC) and the National Economic Council (NEC) and as a director in the International Economic Affairs directorate of the NSC (2002-2005). This request also includes any folders related to Sullivan's brief tenure as Acting Senior Director in the International Economic Affairs directorate of the NSC (June 2004 - August 2004).

Sullivan worked on a wide variety of international trade-related issues, particularly the negotiations of international trade agreements, participation of the United States in the World Trade Organization, and steel issues. He worked very closely with staff members at the Office of the United States Trade Representative (USTR). He regularly traveled to international meetings alongside Ambassador Robert B. Zoellick, the United States Trade Representative.

Sullivan's staff member office files were originally intermingled with the files of John Herrmann, a NSC staffer in the International Economic Affairs directorate after Sullivan's departure in 2004. There is a very small amount of material from Herrman mixed within this collection. These items can be identified in two ways: they date outside of 2002-2004 or have Herrmann written in the top right-hand corner of the page. It is possible Herrmann utilized Sullivan's files during his work at the NSC and that led to this intermingling of material.

Sullivan's staff member office files are arranged in four series: Region Files, Subject Files, Steel Files, and General Files. All series are arranged alphabetically. Each series contains memoranda, reports, cables, emails, USTR Trade Policy Review Group and Trade Policy Staff Committee discussion papers, handwritten notes, talking points, briefing papers, meeting agendas, summary of conclusions, and news articles.

Region Files pertain to the free trade agreement negotiations with nations such as Australia and Bahrain and formal regional economic groups such as the FTAA (Free Trade Area of the Americas) and SACU (South African Customs Unit). There are materials related to World Trade Organization activities such as the Doha Development Round ministerial in Cancun and formal trade disputes between the United States and other member countries. There is a large grouping of material related to China-United States trade.

Subject Files contains a grouping of folders that were originally arranged in alphabetical order. This material includes a wide cross-cut of topics Sullivan worked on including free trade agreement negotiations, steel issues, and World Trade Organization-related topics.

Steel Files relates to the 2002 Bush administration decision to impose a Trade Act of 1974 Section 201 tariff on imported steel and the subsequent lifting of this tariff in 2003. Material related to the European Union's decision to impose retaliatory tariffs and the case filed with the World Trade Organization Dispute Settlement Body regarding the fairness of the United States' tariff is represented.

General Files consists of all folders that did not fit into the three aforementioned series. Topics such as World Trade Organization negotiations, the fifth World Trade Organization Ministerial Conference in Cancun, Mexico, in September 2003, intellectual property rights, the development of standard free trade agreement criteria, and issues related to specific commodities such as coffee and cotton are contained within this series.

The only folder responsive to the request outside of Sullivan's office files is a folder entitled "Travel – Dan Sullivan." This folder primarily contains administrative travel documents such as authorizations, vouchers, and receipts. Some briefings, schedules, and routine memos are also included.

It should be noted that many of the documents listed here may have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.

System of Arrangement

The materials in FOIA 2014-0302-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Sullivan's staff member office files are arranged in four series. All series are arranged alphabetically.

Documents responsive to this FOIA were found in this collection area – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
