Biographical History: Susan Buckland headed the Virginia Department of Deaf and Hard-of-Hearing before working for the Department of Labor in the administration of George W. Bush. While working at the Department of Labor, Buckland was detailed to the White House Domestic Policy Council where she worked with administration officials and other government agencies on the needs and issues of persons with disabilities.
