**Abstract:** Jay Lefkowitz served as Deputy Assistant to the President from 2002-2003 in the Domestic Policy Council. This collection contains a large quantity of policy making material on a wide variety of topics including abortion and stem cells, education, homeland security, health and safety, crime and drugs, housing, immigration, transportation, September 11<sup>th</sup>, and veterans' issues. International issues such as AIDS, terrorism, and abortion as well as meetings with the UN are also represented.

**Biographical History:** Lefkowitz was born in 1962 in Albany, New York and raised in a Jewish family. He earned an undergraduate degree in history from Columbia University in New York, New York in 1984 and a law degree in 1987. After graduating, he obtained a position with the Paul Weiss law firm. During the George H. W. Bush administration, he served as Director of Cabinet Affairs and Deputy Executive Secretary to the Domestic Policy Council. Following the

end of the administration in 1993, he joined the New York office of the international law firm Kirkland & Ellis, where he eventually became partner.

During the George W. Bush administration, Lefkowitz first served as General Counsel for the Office of Management and Budget. In 2002, he became Deputy Assistant to the President for Domestic Policy. After departing the White House in 2003, Lefkowitz returned to Kirkland & Ellis and has worked on high profile legal cases involving government agencies such as the Food and Drug Administration, and large corporations including Verizon and General Motors. From 2005-2009, he served on the United States' Special Envoy on Human Rights in North Korea.

Lefkowitz and his wife, Elena, married in 1991 and have three children. They are heavily involved in the Jewish community in New York.

**Scope and Content Note:** This collection is arranged in two series. The first series, Subject Files, is arranged alphabetically in two A-Z segments. There were two distinct groupings of boxes attributed to Lefkowitz that were each arranged alphabetically, therefore this arrangement has been preserved. The second series, Administrative Files, is arranged alphabetically.

All of Lefkowitz's files were maintained by his assistant, Lauren Vestewig. Many items were sent directly to her, so her name appears frequently throughout the collection. Large quantities of items feature filing categories in her handwriting at the top right-hand corner of the first page. A grouping of boxes attributed to Lefkowitz was originally described as belonging to Kristen Silverberg, a staffer in the White House Office of the Chief of Staff. This material physically and intellectually matched the boxes attributed to Lefkowitz and was integrated with his material during processing. However, there are several folders that potentially contain Silverberg materials. It is unclear if or how she utilized Lefkowitz's files during the administration or if this was a description error.

Subject Files consists of memoranda, emails, correspondence, reports, legislation, notes, and related material on a huge variety of topics including abortion and stem cells, education, homeland security, health and safety, crime and drugs, housing, immigration, transportation, September 11<sup>th</sup>, and veterans' issues. International issues such as AIDS, terrorism, and abortion as well as meetings with the UN are also represented.

Administrative Files contain an address book.

**System of Arrangement:** The collection is arranged in two series. The first series is arranged alphabetically in two A-Z segments and the second is arranged alphabetically.
