FOIA 2019-0236-F requested materials related to the final passenger manifests for Air Force One for President George W. Bush's trips to Africa on July 8 - 12, 2003 and February 16 - 21, 2008.

This FOIA primarily contains the Presidential Daily Diary for President George W. Bush from July 8 - 12, 2003 and February 16 - 21, 2008, for trips to Senegal, South Africa, Botswana, Uganda, Nigeria, Benin, Tanzania, Rwanda, Ghana, and Liberia.

## **System of Arrangement**

The materials in FOIA 2019-0236-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
