#### **Scope and Content**

The materials in FOIA 2018-0263-F[48] are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2018-0263-F[48] requested previously unprocessed materials related to emails sent or received by Brett Kavanaugh referencing Voting Rights Act between July 2003 and May 2006.

This FOIA primarily contains night notes, cabinet reports, and a pool report regarding the Voting Rights Act. Records from this segment date from October 29, 2004 to June 1, 2006.

#### System of Arrangement

The materials in FOIA 2018-0263-F[48] are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

#### George W. Bush Electronic Records

Voting Rights Act 40Days contains 9 assets, of which 1 is released in full, 0 are withheld in full, and 8 are withheld in part.

Voting Rights Act RNCPST\_1 contains 180 assets, of which 12 are released in full, 0 are withheld in full, and 168 are withheld in part.

Voting Rights Act RNCPST\_2 contains 335 assets, of which 262 are released in full, 22 are withheld in full, and 51 are withheld in part.
