



## Inventory for FOIA Request 2017-0201-F

### Records from White House Office of Records Management Files Containing Any Reference to Bill Gates, Founder of Microsoft

#### Extent

242 folders, approximately 13,194 pages

#### Access

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### Copyright

Records in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### Scope and Content

The materials in FOIA 2017-0201-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2017-0201-F requested materials from White House Office of Records Management files that contain any reference to Microsoft founder Bill Gates.

This FOIA primarily contains presidential schedules and event memoranda, guest lists for White House events, speech drafts, drafts of White House Messages sent to individuals and organizations, printed emails, and public and outgoing White House correspondence. The bulk of the material in this FOIA consists of invitations, correspondence, and reports to and from White House Chiefs of Staff Andrew (Andy) Card and Joshua (Josh) Bolten, and Senior Advisor Karl Rove.

Researchers should note that because George W. Bush Presidential records are processed at the folder level, each folder will have at least one record about or referring Bill Gates. However, the vast majority of the material processed for this FOIA does not pertain to Mr. Gates.

### **System of Arrangement**

The materials in FOIA 2017-0201-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM).

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
