#### Scope and Content

FOIA 2024-0033-F requested materials related to emails between Karl Rove and Michael Gerson with the keywords tax or taxes.

This FOIA primarily contains speech drafts and comments, policy discussion, and articles with commentary and discussion.

#### System of Arrangement

The materials in FOIA 2024-0033-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

The following is a list of electronic search results lists (SRLs) processed in response to FOIA 2024-0033-F:

***George W. Bush Electronic Records***

ARMS contains 23 assets, of which 22 are released in full, 0 are withheld in part, and 1 is withheld in full.

Exchange contains 36 assets, of which 32 are released in full, 2 are withheld in part, and 2 are withheld in full.

Exchange 40 Days contains 6 assets, of which 3 are released in full, 0 are withheld in part, and 3 are withheld in full.

RNC contains 2 assets, all of which are released in full.
