Scope and Content

The materials in FOIA 2016-0072-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2016-0072-F requested materials related to records from the files of Jendayi Frazer related to the genocide in the Darfur region of Sudan.

This FOIA primarily contains records regarding the Sudan Peace Act, drafts of the Sudan Peace Act report, fact sheets, an Africa report for the G8, invitations to meetings by outside organizations, news articles with commentary, and draft testimony. Records date from 2003-2004 during Frazer's time at the NSC before becoming Ambassador to South Africa in 2004.

It should be noted that many of the records in this FOIA have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2016-0072-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

ARMS contains 12 assets, all of which are released in full. Exchange contains 62 assets, of which 29 are released in full, 7 are withheld in part, and 26 are withheld in full.
