#### **Extent**

#### **Access**

Collection is open to all researchers. Access to George W. Bush Presidential records is governed by the Presidential Records Act (PRA) (44 USC 22, as amended) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

FOIA 2024-0154-F requested materials related to emails with Bulletin News about White House News Summaries and White House News Clips from 1/20/2001-3/31/2001.

This FOIA primarily contains questions and responses regarding search criteria and tactics, delivery timing, a proposal regarding regional news clips and television news, a proposal regarding the White House News Summary and White House News Clips, discussion of the White House News Summary, discussion of news sources and timing, and emails requesting articles be included.

### **System of Arrangement**

The materials in FOIA 2024-0154-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
