#### **Extent**

155 assets

#### **Access**

Collection is open to all researchers. Access to George W. #### **Scope and Content**

The materials in FOIA 2024-0170-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2024-0170-F requested materials related to emails between Josh Bolten and Gary Edson containing AIDS, HIV, or Africa from June 1, 2002 to February 1, 2003.

This FOIA primarily contains emails regarding an HIV plan and launch of the plan, inquiries regarding the new plan, information regarding different AIDS initiatives, news articles with commentary, meeting information, forwarding messages from Anthony Fauci, and emails with and regarding Bono and Bono's staff and AIDS initiatives.

### **System of Arrangement**

The materials in FOIA 2024-0170-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House’s electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
