Scope and Content

The materials in FOIA 2016-0185-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2016-0185-F requested materials related to the Staff Member Office Files of Scott McClellan.

This FOIA primarily contains correspondence, schedule proposals and schedules, gift records, photo and autograph requests, resumes, travel vouchers, briefing slides, charts, talking points, press releases, fact sheets, reports, news clippings and webpages. There are two sub-series contained within Scott McClellan's files, Meeting Notes and Subject Files. The Meeting Notes are a chronological file of hand-written notes taken by Scott McClellan during various meetings he attended while serving as Press Secretary. This subseries also contains phone messages and partial transcripts of some press briefings. The Subject Files are and alphabetical file regarding

various subjects which include but are not limited to Affordable Healthcare, Embryonic Stem Cell Research, Faith-Based and Community Initiatives, Immigration, Iraq (as well as numerous other countries), Social Security Reform, the Space Shuttle Columbia disaster, and Weapons of Mass Destruction (WMD). There are also files related to questions regarding President George W. Bush's National Guard service.

It should be noted that many of the records in this FOIA have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.

System of Arrangement

The materials in FOIA 2016-0185-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
