Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and are administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2024-0169-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2024-0169-F requested materials related to a December 4, 2002 meeting that discussed an AIDS initiative and the State of the Union address.

This FOIA primarily contains drafts of a PowerPoint presentation, a Policy Time briefing paper, a meeting reminder email, an email regarding the global HIV plan, a memorandum about CDC HIV/AIDS testing recommendations, a briefing about the President's Emergency Plan for AIDS Relief (PEPFAR), and a January 2003 meeting agenda regarding an upcoming meeting with the President's Advisory Council on HIV and AIDS (PACHA).

System of Arrangement

The materials in FOIA 2024-0169-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
