FOIA 2024-0183-F requested materials related to emails between Gary Edson and Anthony Fauci containing AIDS, HIV, or Africa from February 1, 2003 to March 1, 2003.

This FOIA primarily contains drafts of an op-ed by Anthony Fauci with comments, an email regarding a press inquiry, emails regarding draft talking points, and questions and answers.

System of Arrangement

The materials in FOIA 2024-0183-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House’s electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
